This research discussed the study of linguistics in diagnosing hate speech against Vladimir Putin in Social Media Twitter. The method research applied in this research was qualitative method. The research objective were; To describe type of hate speech of netizen's comment against Vladimir Putin On social media twitter and to describe type of illocutionary act of speech act of netizen's comment against Vladimir Putin on social media twitter. The sources of data was taken from social media twitter. the data were analysed and categorized based on the type of hate speech and type of illocutionary act. the findings from this source were 58 hate comment, which consist of the type of hate speech, which consist of 4 provoking, 7 inciting, 4 spread hoax, 3 unpleasant action, 8 insulting, 1 defamation, 2 denigration. The researcher finding 12 assertive, 6 directive, 5 expressive, 2 declarative, and 4 commissive.

CHAPTER I

INTRODUCTION

A. Background of Study

As long as the develop of social media, hate speech be a highlight in today's generation people can express their opinion or though trough the tool that can be used to convey to express their opinion in a written form, picture, or video. Mostly hate speech act is found in written form. In this era is free to express their opinion or through with their own language. By language people can communicate each other. Communication is an art of creating and sharing idea, moreover communication is a proses of exchanging feelings, emotions, ideas, through and information by speech, gesture, symbol, signals, writing and many more. with language, written, picture and video.

Hate speech act is an act of communication carried out by an individual or group in the form of provoking, incitement or insult other individual or group in various ways aspect such as race, skin tone, religion gender, sexual orientation, nationality and many others. The hate speech act can be carried out through various media, including speech in campaign activities, social media network, public delivery and many other electronic media.

Mostly hate speech act is directed by people who have power, influencers, artist or people who have a good images. In this study the researcher focused on hate speech aimed at Vladimir Putin through social media twitter. Hate speech can overflow of negative emotions through these words can see from the perspective of the speech partner or listener and the speaker perspective. Speech hated is impolite when viewed from the viewed from the partners perspective that can be an action that has intentions from the speakers.

Hate speech is a hateful message or act of communication that is offensive and insulting with the aim of hurting the feelings of certain individuals or groups which proves that most cases of hate speech occur based on ethnicity, nationality, and religion. This indicates that hate speech does not originate from social media, but develops because of the emergence of new media that seem to make it easier for perpetrators to do so.

Speech act in speech event are two symptoms can be occour in a process, namely the process of communication. In the human life cannot be separated from speech events, because human speech can convey the information to their interlocutors and can understand each other.

Analyse of hate speech is needed to know the meaning of the hate speech and the form of hate speech by the utterance of the netizen because many types of hate speech and the intention of the netizen so it needed the study about speech act. to know the intention of utters the study about speech act especially about illocutionary is needed. Illocutionary are speech act that contain function and intention of speech, it can identify as speech act that function to inform something and do something by the utterance.

The object of hate speech act is someone who famous, have a popularity, for example, celebgram, youtuber, actress, influencer of even president. Hate speech act against certain social media to attack the object by the utterance of the netizen in comment column.

Illocutionary refers to as the act of doing something, furthermore according to Searle (1967) illocutionary speech act are classified into five type of speech form, which in each has a communication function. In five types of speech act show the function that can be summarized as representative, directives, commissive, expressive, declarative.(Rosyidi et al., 2019).

The need of expressing idea, information, opinion, or through were completed well by social media like twitter. This kind of social media was used to share or post the idea, information, opinion, though, photo or video by the user to another users then, the followers or netizen were able to retweet or leave the comment in comments column to deliver their responses or opinion based on the activities that users shared. In this case if look at the comment column, we would find some rude words, rough word, offensive word, or dirty word which was used to attack someone they did not like, that was called hate speech.

In twitter people free to express their though or to post something. The freedom of speech that make the user on twitter free to do the hate speech act beside another social media. According to Directorate of Criminal Investigation Cyber Police, there are 125 account of social media get reprimanded by cyber police related to contain indicate of the element hate speech act. From the 125 account, twitter has the largest account of 75 account (Perwira & Dwitama, 2021)

The object of this research is netizen comment against Vladimir putin on social media twitter. It will be find out the speech of netizen against Vladimir Putin and analyse the type of hate speech and the type of illocutionary speech act utterance by the netizen on social media twitter.

Therefore, it will be interested to conducting research entitled Diagnosing Hate Speech Act Against Vladimir Putin on Social Media Twitter. The purpose of this study is to diagnosing by analyse the hate speech act and the illocutionary speech act in netizen comment on social media.

B. The Identification of the Problem

Based on the background of the study, the identification of the problem are:

- The use of types of hate speech act to analyse the netizen's comment in social media twitter
- 2. There are the differences of the hate speech act of Vladimir putin on social media twitter.

C. Scope and Limitation

The scope of this research is confined the hate speech act of netizen's comment against Vladimir Putin on Social Media which focused on the type of hate speech. from the theory of the Criminal Code Number: SE / 06 / X / 2015 namely insults, denigration, defamation, unpleasant acts, provoking, inciting, spread hoaxes (Hoax).

D. Formulation of the Problem

The formulation of the problem are formulated as follow :

- 1. How is the type of hate speech act against Vladimir Putin On social media twitter?
- 2. How is the illocutionary act of speech act of netizen's comment against Vladimir Putin on social media twitter?

E. The Objective of the Study

- To describe type of hate speech of netizen's comment against Vladimir Putin On social media twitter.
- 2. To describe type of illocutionary act of speech act of netizen's comment against Vladimir Putin on social media twitter.

CHAPTER II

THE REVIEW OF THE LITERATURE

A. Theoretical Framework

Theories are required in research to explain some notions in the research issue. To have the same viewpoint of implementation in the field, the notion that was employed must be explained. Theoretical explanations of the concept employed in this study will be offered. In other words, the following is thought to be significant to discuss so that the reader understanding the idea better.

1. Speech Act

Speech is the process of building and sharing meaning through the use of verbal and nonverbal symbols, according to Searle (1969) linguistics communication involved linguistic act. The unit of linguistic communication is generally, the symbol of word, in the performance of a speech act and there is a shift toward acts that occur via language and it's performed in the utterance of a sentence are in general (Journal & kajian Bahasa dan Budaya, 2020).

2. Hate Speech

Hate speech from the term "hate", as well as the kind of speech known as "hate speech" and the phrase "hate", may be distracting on demonstrates that people are concerned with correcting the feeling and emotions at the roof of particular speech act. The term of emphasizes the subjective attitude of the person who expresses, promotes, or publishes a hateful message toward another person.

Hate speech is a definition for action crimes related to swear words insult against individuals or groups on the basis of race, sex, orientation, ethnicity and religion. Where the act is a form of humiliation creates an atmosphere or hostility, intimidation and part of pollution (Brison, 1998)

According to Ubaidillah Hate speech is not just an emotional expression against a particular individual conveyed through interpersonal channels but expressed hatred is based on fundamental human characteristics. This public channel factor and fundamental communal character make hate speech can cause mass damage. Hate speech is not only about shared knowledge but also desires and hatred. The purpose of hate speeches is to give the addressee the knowledge unknown before and make them want something never thought of and feel something (Ubaidillah & Wijana D.P, 2021)

Hate speech is an act carried out by certain individuals or group in the form of provocation, incitement, insult, blasphemy, defamation or spread of hoaxes in aspect like, skin tone, race, gender, ethnicity, physical disability and many more (Indah et al., 2020) Moving on from this kind of understanding, it can be said that all expressions or fate speech are realized through both verbal and nonverbal language that aims to discriminate, intimidate, dominate and create hostility and violence.

According to Alexandra hate speech can be extremely broad or fairy narrow, the definition capture a wide variety of speech that is directed against a specified or easily identifiable individual or groups based on arbitrary or normatively irrelevant features (Siegel, n.d.).

3. Types of Hate Speech

Hate speech is a part of the crime of hatred, according to Permatsari and Subyantoro there are six types of hate speech, provoking, inciting, spread hoaxes, unpleasant action, insulting and defamation base on the chief of Police Circular Number SE / 06 / X / 2005. (Indah et al., 2020)

a. Provoking

Provoking is a speech to make someone or people angry, provoking can be defined as an expression of incitement to discrimination violence and hostility. Speech delivered in this case triggered a public misunderstanding and would have an impact on hostility or war. Provoking is an act done for arouse anger in a way to annoyance and make people who agitated have negative thought and emotions.

According to KBBI provoking is an act done to arouse by inciting, anger, irritation, provoking and making the person who was incite have negative though and emotion. provoking could be incredible action within the shape of articulations to warm up a person or community bunch and cause fear, uneasiness in a community. Speech conveyed, in this case, activated an open misconception and would have an effect on hostility or war. the example of provoking, '*' just delete his twitter account* ''. the sentences referred to the provoking in by making people who read it incite the negative though. In the sentences provoke people by suggesting the people to delete the twitter account of someone.

`` the immigrant were all just give the fault for the country''. the utterance of the sentences referred to provoking, in the sentences shown the discrimination that attached the immigrant.

'' you know, he just a looser, he even can not be a leader. stop support him!!'''. the utterance sentences referred to the provoking because the sentence incite the negative though and contain an anger. the sentence he even can not be a leader is force people to believe that the person just a looser, the speaker want to tell that they have to stop to support someone by the negative though.

b. Inciting

Inciting is the word or sentence which has the intention of encouraging, persuading, rising up or inflaming the spirit of someone to do something. The word '' incite'' has the attribute '' intentionally''. Inciting is almost the same as the provoking shape, but the shape of the inciting speech is more subtle than provoking the predominantly rude speech. An instigator could be an articulation or utterance that impacts other individuals and aims to make the individual believe it. This speech will stimulate someone's heart to be irate, to stand up to, revolt against something certain people or groups.

Examples of incitement utterances. "Yeah, just kill it instead of making a fuss, I also hate him because he's a black man." The utterance is a form of inciting

because the speaker invites the interlocutor to kill someone because of the reason that the group of people is Chinese. The utterance is an invitation to do something but not forced.

the sentences "*bring trump down 2020*" such as the type of provoking because in the sentences persuade the people to drop the president Donald Trump down from his position as a president.

the sentences '' you are crazy guy '' is an inciting because in this sentences the word crazy is a cruel word for labelling someone that the word crazy means a person has mentally ill.

c. Spread hoaxes (hoax)

Spread hoaxes or hoax is the expressions of hatred by spreading the news that is actually not true (lying) or known as hoax news aims that order people trust the people can no longer choose whether the news is true or not. Example in utterance in this form of spreading fake news. *Child abductions that occur in Indonesia are very cruel, children who are kidnapped are mutilated and burned and thrown away.* The statement is spreading a fake news or hoax because the abduction is happened but the children is not be mutilated or even burried they just trapped in a house or building and the kidnapper will ask for money to free the children.

"there will be tspread hahe big disaster in next year". the utterance of this sentences referred to spread hoax by order to make people trust the sentences but it actually not true. this sentences aimed to share the news that untrue or hoax,

this sentence was made to make people believe about what will be happened just to want to get the attention of others.

"Biden is a big worst, lets close him from America". the utterance of this sentences referred to spread hoax. the sentences is not true based on the fact and reality. by saying biden is a big worst the speaker want people to believe that he is a big worst and make other hate him.

d. Unpleasant action

The definition of unpleasant action is a speech that contain threats, coercion, violence or oath. This unpleasant behaviour indirectly interferes with the comfort and safety of individuals and groups. Example of utterance in unpleasant action "*if you not give me the money, I will hurt your daughter*". The utterance includes unpleasant actions because the speaker forces the interlocutor to give him the money, and threatens to hurt his daughter if the speech partner does not obey his speech.

``resign!! you cant do anything.'', the utterance of the sentence includes unpleasant action because word resign was an impolite annoying in commanding someone. the sentences forces the interlocutor to quit on his job by saying the interlocutor can not do anything.

``you have to give me the position, I'll make you die if you don't want to ``. the utterance of the sentences referred to unpleasant action, this sentences contain the coercion and violence. it force the interlocutor by coercing to give the position and will do the violence by saying die or will kill the interlocutor.

e. Insulting

Insulting is attacking the honour and prestige of a person. Insult was defined as an action if an insult is directed at a person or group of people based on religion, race, ethnicity, religion, gender, disability, sexual orientation. Insulting is an action to bring down one's soul. Usually this insulting is carried out by expressing utterance that contain harsh words, invective which impairs one's reputation and honour.

Insulting is attacking someone's honour and good name. Those who are attacked are usually embarrassed. The object of insulting is in the form of a sense of self-esteem or dignity regarding honour and about the good name of people, both

individually and communally (groups). Examples of insults. *Bandung is a city junkie who needs all prostitutes LOL hahaha report? Sissy! Please if you dare! Ha ha ha.* The statement is a form of insult to a city in West Java (Bandung) by saying that Bandung is a city of prostitutes. The speaker also mentioned that all the people of Bandung work as prostitutes.

"Wild dog, stop killing india muslims".the utterance of the sentenecs was a insulting . in The word "dog" was referred to the types of hate speech of insulting. This was because the interlocutor who as a human was called as an animal that had the meaning brainless, predatory, savage, uncontrollable, and careless.and it bring the religion of muslim,

'Who cares. You sure are insane. You need to be removed from office 'The utterance was intended to insulting. The sentence was referred to the types of hate speech of insulting. The word "insane" means crazy or mentally ill. It was cruel word in labelling someone.

f. Defamation

Defamation is the act of defaming someone's prestige or honour by stating something in spoken or written. Example of defamation in utterance, *Members of parliament and the lawyer are imbecilic doltish legal counselors*. The utterance is a form of defamation against members of the DPR, the speaker thinks that the DPR members are stupid and stupid, besides that the speaker also thinks that the lawyer who helps the guilty is a stupid lawyer. The speaker defamed the government agency of the DPR by using the words stupid and stupid, and defamed one of the lawyers by calling him a moron.

"You are with holding tests and refusing widespread testing that would provide states with respirators and equipment. You and your crime family are personally making hundreds of millions of dollars." The sentence was referred to the types of hate speech of defamation. It showed that the sentence "refusing widespread testing" had the meaning that the interlocutor did not help his citizen to handle the corona virus spreading. The second sentence "you and your crime family are personally making hundreds of millions of dollars" means that the netizen accused the interlocutor was saving the money for his own self or as a corruptor.

g. Denigration

Denigration is a word, behavior, writing, or performance that is prohibited because it can trigger acts of violence and prejudice either on the part of the perpetrator of the statement or the victim of the act, the example of denigration utterance "*I will not choose Ahok to be governor of DKI because he is an infidel and has caused a commotion in Jakarta because of his actions*". The statement is considered denigration, because the speaker said that because of Ahok's actions, Jakarta became noisy. The speaker also spoke of denigration by calling Ahok an infidel, and would not elect him to be governor of DKI Jakarta for religious reasons.

"Stop giving wrong information about COVID-19. 50000 cases in USA.Shame on you president. And you still worry about economy. Look at INDIA. it's lock down already. You let your people die". The sentence was referred to the types of hate speech of denigration. It was because the netizen accused the president or interlocutor always gives the wrong information about Covid-19 or it was called as hoax. The netizen said that the interlocutor spread the hoax about Covid-19. And the sentence "You let your people die" was also defamation. It had the meaning that the interlocutor did not care about his citizen's recovery of Covid-19.

"Stop taking credit for nothing you did. We will thank the democrats. You have done so much damage. There is a special place in hell for you and your family ". The sentences were referred to the types of hate speech of denigration. the sentences contain about the prejudice of the interlocutor. The sentence of "stop taking credit for nothing you did" meant the netizen accused that the people always lies and creates his image as a good person.

4. Illocutionary act

Speech act is divided into three parts: locutionary act, illocutionary act and perlocutionary act. Speech act theory is foundation of the study pragmatics. speech act is the utterance intended to state something so that the intention of the speaker to be understand, it is focused on how to use language in communicating intention and purposes (Nasution et al., n.d.).

According to Wijayana, Illocutionary act refers as an act of doing something. Illocutionary are speech acts that contain intentions and functions or power of speech. Illocutionary speech acts can be identified as speech acts that function to inform something and do something and contain intentions and utterances. Illocutionary act are not easily identified because it is related to who the speaker is, to whom, when and where the speech act is performed.(Rosyidi et al., 2019b) . Illocutionary is an act of utterance that has certain powers such as commanding, warning, and doing something (Oktaviani et al., 2022).

5. Types of illocutionary act

Searle (1979) classifies illocutionary act into five categories, namely: assertive, commissive, expressive and declarative.

a. Assertive

Assertive or representative is a speech act of stating, proposing, bragging, complaining, expressing opinions, and reporting. The speaker is committed, in varying degree to the truth or false of a proposition, stating, informing, affirming,

boasting, complaining, denying and others. (Ilyas & Khushi, 2012) Assertive illocutionary n is an assertive act counts as an attempt to explain the actual state of affairs comprising phrases used to address a specific idea, proposition or belief.

The example of assertive utterance, *stupid! Pull your self together. Person who have a power but out of contex.* The utterance of assertive is convey about an opinion of the privilege context. Following assertive illocution is a speech used to convey a particular idea, where the speakers attached to the truth of the proposition expressed or confidence expressed to listeners such as affirming something, informing things, concluding, and reporting something.

"Who cares. You sure are insane. You need to be removed from office" The sentence referred to the types of illocutionary act of assertive. It was because the netizen stated the interlocutor as an insane or a crazy person and couldn't be a president anymore. The word of "stating" is a kind of assertive act.

'We're not listening anymore. It seems we're self governing at this point there is no leadership''. the utterance of assertive is coney about complaining the government, in this point the interlocutor attached the government by saying there is no leadership.

"Jokowi is the worst president in history". The sentence referred to the types of illocutionary act of assertive act. It was because the sentence stated that President Jokowi was not skillfull and qualified to be a president. The word of "stating" is a kind of assertive act.

b. Directive

The directive is the act of speech used by the person who speak in order to be able to order the interlocutor to carry out certain actions. This utterance explains a will or will of the speaker. These speech acts include; requests, orders, suggestions, the act of ordering, and its form can be like negative and positive sentences. When using directives, the speaker tries to harmonize the world with a series of words through the interlocutor.

Directive is a speech that aims to produce an effect to a listener in the form of an action or has the intention to make a listener to do something. The functions of directive speech acts) are ordering, commanding, begging, demanding, and advising. The speaker tries to get the hearer to do something, e.g. advising, asking, begging, challenging, commanding, recommending, requesting, and suggesting. The example of directive utterance, *go to hell with your family!*. The utterance is a directive illocutionary because the of asking or request or praying for something bad.

'Please don't talk. You are a crazy person'' The sentence referred to the types of illocutionary act of directives.. The word "please" was a request word. And the word "don't" was a command word. These request and command words were kind of directives act.

"Print some extra money, and steel the medicine from Europe, the Russians are helping Italy, did not hear anything of this sick men. So called fake friend". The sentence referred to the types of illocutionary act of directive act. It was because the netizen in the first statement suggested the people to get the money by own self and not to hope the president took care of them. The continuous sentence was stating sentence that netizen informed that the netizen didn't want to listen to the man. The word of stating and suggesting were assertive act.

'I cannot understand how you Americans can vote him. He's so incoherent''. The sentence referred to the types of illocutionary act of assertive act. It was because the netizen expressed the mind of the netizen. The word of expressing was an showing an opinion.

c. Commissive

Commissive act is a speech act where the speakers attached to an action in the future. These commissive act includes promising, offering, and swearing. Commissive is an act of utterance the speaker can understand or understand the deed done and expresses a willingness to do this in life. These speech acts state what the speaker means. The speech act obtains, among others' threats, promises, pledges, refusals, and can be shown to the speaker or the speaker becomes part of the group. When using commissive, the speaker seeks to harmonize the surrounding environment with the sequence of words through the speaker.

The speaker committed, in varying degrees, to result in an obligation to speaker. That is they commit the speaker to so something e.g. guarantee, offering, promising, swearing, threatening and vowing. Example of commissive, *shit! You are so rough*. the utterance of commissive in illocutionary act is express the swear of someone.

``I promise to help you to get your dream`'. the utterance of sentences is a commissive, the sentences contain promise. the speaker perform an action in the future, the classification of commissive in illocutionary act include promise.

'Big fucking deal! The rest of the world is also moving their income tax deadline as well, this fucking guy thinks he's the first LMAO''. The sentence was referred to commissive, this sentences contain the swearing or a hars word. the word fucking deals and fucking man sow the swearing, This statement show hatred to the government about the tax.

d. Expressive

Expressive is a speech act that expresses an utterance the speaker can feel it. The speech act describes the state of things stated psychologically and the statement can consist of liking, joy, pleasure, hatred, misery, and trouble. Expressive is a speech act which has the function as a disclosure of psychological attitude of the speaker toward the state implied in the illocution. The action to express this expressive attitude is like to say thank you, congratulate, apologize, blame, praise, and say condolences.

These speech acts the listener or speaker does something, but all of them are related to what the speaker has experienced. When using expressiveness the speaker matches a series of words by feeling something. The speaker expresses an attitude and feeling about a state of affairs, e.g. apologizing, blaming, congratulation, pardoning, thanking, and welcoming. The example of expressive utterance, *you destroy everything! Think about other don't just think for yourself.* the utterance of expressive is express about the feeling of he or her in blaming something in hate speech utterance.

" congratulation, you already broke my day!! ". the utterance of the sentences is express the expressive in illocutionary act. it shown to congratulate someone in hated.

`` sorry for coming, but I need to know the truth'. the utterance of the sentences is express the expressive by state the pardoning to shown the feeling of the speaker.

"You made the corona virus yourself". The sentence referred to the types of illocutionary act of expressive act. It was because the netizen blamed that Corona-virus was created by someone. The word of blaming was a kind of expressive act

e. Declarative

Declaration is a speech act that can change environment through speech. Speakers in special contexts, must has a special institutional role, to put forward a statement correctly and precisely. Declarative is a speech that falls into the category of a very specific act of saying such as firing, punishing, and hiring. This speech act is intended to create things such as status, circumstances and so forth from the speakers to the said partner When expressing a statement the speaker can change the surrounding environment with a series of words.

Declarative is a speech that falls into the category of a very specific act of saying such as firing, punishing, and hiring. This speech act is intended to create

things such as status, circumstances and so forth from the speakers The word or expression that changed the world by utterances such as bet, declare, resign.

"You're not a clown you're the whole circus". the utterance of the sentences referred to declarative. This sentences contain the expression that the interlocutor by saying that change the person or in this sentences is a clown be a circus, this sentences shown the circumstances of the interlocutor.

'You are collapsing the economy instead of just isolating sick and old people? Have you lost your mind – this idiotic move is going to carry a 10 trillion dollar price tag''. the utterance of the sentences referred to declarative illocutionary act. the sentences you are collapsing the economy declare the status that the person was a corruptor who make the inflation impact for the country.

B. Relevant Study

In this research, a view previous researchers do the same research about hate speech but have a different focus. The first previous study is a thesis entitled, Hate Speech Comment on Donald Trump's Instagram Photos semantic study by Lusiana Sondra of Adab and Humanity Faculty the State Islamic University Sultan Thaha Sifuddin Jambi. The purpose of this study is to analyse the hate speech used in social media Instagram. The background of this study is to analyse the hate speech words that used in social media by people today they are do not know the meaning when using it. The material of this research is the word of comments on Donald Trump Instagram Photos. The purpose of this research are to find out type of hate speech words on Comments Donald Trump''s Instagram Photos Semantics Study, to find out the lexical and contextual meaning of hate speech words to find out the effect of hate speech comments.

The research design is library research that used qualitative research method to analyse the data. This research also used documentation technique to get the data. The result of this research shows the data based on the formulation of problem. They are, there are two types of hate speech; expression of insult and ridicule or slander that used in the commentary of Donald Trump''s Instagram Photos. there are two kinds of meaning; lexical meaning and contextual meaning. there is the effect of hate speech comments; the reaction of the reader or audience.

The similarity of this research is about diagnosing the hate speech in social media. The difference between the previous research with this study is the object of this study that is Vladimir Putin and this study use the theory from permatasari about the type of speech hate, that are, provoking, insiting, hoax, unpleasant action, defamation.

The second previous research is a journal entitle, impoliteness in Indonesian language hate speech on social media contain in the Instagram account. conducted by Subyantoro and Sigit Apriyanto. This research is analyse the phenomenon of the hate speech in Indonesia language, and the expression that stimulates people from certain social groups that are oriented toward differences, race, national origin, religion, and gender.

In this study, the analysis of the hate speech is seen from the perspective of the impoliteness theory. The research uses forensic theory, while the methodology uses qualitative. The data used, as many as 40 comments were used as research objects. Realization of hate speech based on impoliteness, there are 3 strategies, namely positive impoliteness strategies, negative impoliteness strategies, and satire or scoffing strategies. (Subyantoro & Apriyanto, 2020) In other words, linguistic hate speech can be sent in the form of words, phrases, clauses, sentences, and in the form of discourse.

The similarity of this study is analyse the hate speech in social media, the difference between the previous study is the previous study use the impoliteness strategies but this study use the type of hate speech and the illocutionary act to diagnosing the hate speech against Vladimir Putin in Social media twitter.

The third previous study is a journal entitle, the hate speech behavior of teenager on social media intagram, by Firmina Astuti and Partini. The purpose of this study is to understand and describe the hate speech behavior of teenagers on social media Instagram. Methods: This research is a descriptive qualitative research.

In this study the data collection techniques in this study used an open questionnaires that were spread directly. Respondents of the study amounted to 40 people with the criteria of high school / vocational students, have an Instagram account and are willing to become research informants by filling out informed consent. Results: The results showed that the behavior shown by adolescents when they see content that contains elements of hate speech on Instagram, they just neglect the content, keep quiet, do not care, ignore the content and re-porting the content. Regarding the content of the hate speech accounts, some respondents claimed to have been affected by the contents of the hate speech accounts. (Astuti, n.d.). the similarity of this study is the analysis hate speech in social media. the differences between the previous study is the technic of collecting data. This study used qualitative method to analyse the data.

The fourth previous journal entitled, speech act analysis to short stories by Sahar Frouq Alkatiri. This previous study is analysed the kind of speech act in a story (Altikriti, 2011) .the fift previous study is a journal entitle, the illocutionary on speech act of foreign student in indonesia learning. This research is indemnity the type of illocutionary in the speech at through Indonesia learning (Budiasih et al., 2016). The previous study above mostly had researched the hate comment on social media.

All the previous studies finding above help and contribute the researcher understanding of Diagnosing the Hate Speech Against Vladimir Putin on Social Media Twitter. From the previous studies above, it is clear that this study has differences and similarities.

C. CONCEPTUAL FRAMEWORK

Based on the theoretical framework the researcher established the conceptual framework as a basis for the research problem. Hate speech contain the hatred and attack others by word or language. Hate speech is a form of provoking, incitement or insult made to other people, individuals or group by act of communication or speech, by sharing aspect such as ethnic, skin tone, race, gender, nationality, religion and so on. So, in this research the researcher want to examine the diagnosing of hate comment on social media Twitter against Vladimir Putin to analyse hate speech act.




Figure 2.1 : Conceptual Framework

CHAPTER III

RESEARCH METHODOLOGY

A. Research Design

This research conducted to diagnosing the hate speech act based on the type of the hate speech and illocutionary act through applying qualitative research method. Based on Corbin and Strauss (2015) a category of research methodology that produce conclusion without relying on qualitative measurement of statistical analysis is called qualitative research. Qualitative research involves non numerical data such as text, video, or audio. based on the research objective, the researcher will analyse the type of netizen comment of Vladimir Putin on social media twitter.

B. Source of the Data

The data was taken from the comment column of netizen's comment against Vladimir Putin in social media twitter which indicate the hate speech. The source of data taken from February until July 2023.

C. Technique of Data Collection

To obtain data in this study, the data collecting in this research was through documentation method. The data source are hate speech act against Vladimir Putin on twitter. The data collection carried out with the following steps:

- 1. The source of this research is taken through twitter. In collecting data, the data found the hate speech act in comment column against Vladimir Putin.
- after the data was found in comment column in twitter, the data was be documented by screenshot.
- 3. After that, it was identified the type of hate speech act and the illocutionary act
- 4. The final step it was analysed and classified the type of hate speech act and illocutionary act against Vladimir Putin on twitter.

D. Technique of the Data Analysis

Data analysis in this study was done by using a content analysis (John W. Creswell, 2007) The following technique was used to analyse the research data, the researcher used the following technique:

- 1. The researcher found the hate speech and illocutionary act in comment column against Vladimir Putin on twitter.
- The researcher put a marked on the hate speech and illocutionary act against Vladimir Putin on social media Twitter from February until July 2023.
- 3. The researcher analysed and classified the data into each type of hate speech (provoking, inciting, spread hoaxes unpleasant action, insulting, defamation and denigration) and illocutionary act (Assertive, directive, commissive, expressive and declarative)
- 4. The researcher presented the result in the form of table.

CHAPTER IV

RESEARCH FINDING AND DISCUSSION

A. RESEACH FINDING

This research was interested to analyse the netizen's comment against Vladimir Putin in social media twitter that was collecting by taking a note, there are 58 comment against Vladimir Putin which taken to analyse the hate speech act and the illocutionary act. The data analysed by classifying into 7 types of hate speech act, there are provoking, inciting, spread hoaxes unpleasant action, insulting, defamation and denigration and 5 types of illocutionary act, there are Assertive, directive, commissive, expressive and declarative.

B. DISCUSSION

Base on the analysis that has been done, the researcher found the illocutionary act from the hate speech in the comment column against Vladimir Putin in social media twitter. The data of illocutionary act from the hate speech that have been analysed are 58 hate comment against Vladimir putin in social media twitter. The illocutionary act from hate speech contained Assertive, directive, expressive, declarative, and commissive. the type of hate speech from the hate comment contained provoking, inciting, spread hoaxes unpleasant action, insulting, defamation and denigration.

- 1. Type of Hate Speech
 - a. Provoking

Provoking is a type of hate speech that use to make someone angry, it can be defined as an expression of incitement to discrimination violence and hostility. provoking is an act done to arouse by inciting, anger, irritation, provoking and making the person who was incite have negative though and emotion. Based on this data of the study, there are 4 provoking of hate speech found in this study.

Data (01) "He doesn't care. He will kill them".

Data (01) shows the intended against Vladimir Putin, the sentence referred to the types of hate speech of provoking. it was because in the sentences the words ''he will kill them'' is a kind of provoking act that referred to Vladimir Putin and provoke the readers that he will kill people because he is careless.

Data (02) '' Putin loves children especially stealing other people's children''.

From data (01) until data (04) have been analyse and found the word that intended to provoke netizens against Vladimir Putin. the word *he will kill them, stealing, say no to putin, and propaganda* were referred to the type of hate speech act of provoking.

b. inciting

Inciting is a type of hate speech that has the intention of encouraging, persuading, rising up or inflaming the spirit of someone to do something. Based on the data of this study, there are 7 inciting of hate speech found in this study.



Data (05) '' Its time for Rusia to close the door on Putin ''.





Data (10) shows the type of hate speech of inciting. It was because the sentence persuade people to tough that Vladimir Putin was a mistaken and this comment inflaming and give an impact for interlocutor. the word "mistaken" is a kind of inciting act.







CHAPTER V

CONCLUSION AND SUGGESTION

The researcher develops conclusion and suggestion after analysed the data. the conclusion is formed based on the research question whereas advice is offered to the next researchers who have same field with this study. the following portion is suggestion in which in this area the researcher make some advice for the researcher, students, and readers.

A. Conclusion

Based on the result of research the researcher has conducted some conclusion that can be seen based on the hate speech from the comment in comment column against Vladimir Putin in social media twitter. After analysing the data, the researcher conclude that the finding showed that there were 58 of speech act.

From the 58 data the researcher can concluded as the type of hate speech, which consist of 4 provoking, from data (01) until data (04) have been analyse and found the word that intended to provoke netizens against Vladimir Putin. the word he will kill them, stealing, war criminal, and propaganda were referred to the type of hate speech act of provoking.

Inciting of hate speech in this study found 7 data, from data (05) until data (11) shows the words that found in inciting such as, close the door, you are done, kick the bucket, nobody care, fuck, mistaken, and bullshit. there were 4 spread hoax of the type of hate speech from data (12) until data (15) shows the type of hate speech

of spread hoax. the utterance of spread hoax was found the words that used such as, war, genocide, pathetic, and communist use satanic.

Unpleasant action of the type of hate speech was found 3 of data. the utterance od unpleasant action was found from data (16) until data (18), the words of unpleasant action such as , killed, hidden, and sex monster. the words are contain coercion or violence. It found 8 insulting of the type of hate speech, from data (19) until (26) shows insulting of type of hate speech, There were peace, wankers, losers, warn, cry, murder, war criminal, and tiny man which referred to insulting act.

The utterance of defamation of type of hate speech speech found in data (27) the defamation act was found with the word "weird". there were 2 denigration of type of hate speech, the utterance of denigration found in data (28) and (29) the words recovery and end found from the netizen's reply on twitter against the interlocutors.

The type of illocutionary act was found which consist of 12 assertive, the assertive utterance found from data (30) until data (41). the utterance of assertive found from the comment such as , close the doors, war, wins as a genocide, you are done, killed, verry odd, he doesn't care, he will kill them, he is a war criminal, fear us, and losers.

Directive of illocutionary act was found in this study, there 5 of directive in illocutionary act from data (42) until data (47), the words found in directive such as, have you kick the bucked yet?, nobody care, I warn you, should I pray for recovery?, go cry, and under and around.

the utterance of expressive of illocutionary act found from data (48) until data (52). the words found such as, for murder of innocent people, pathetic, fuck, child sex monster, and sadly mistaken, the declarative of illocutionary act was found from data (53) until (54). the utterance of the data found the words propaganda and ended like Adolph Hitler to state the declaration of illocutionary act.

the utterance of commissive of illocutionary act found 4 data. the data (55) until data (58) shows the commissive act, the words was found such as, conflicted, bullshit, tiny man, shits and cowardly war criminal.

B. Suggestion

regarding to the conclusion of Diagnosing hate speech act against Vladimir Putin on social media twitter, the following are written as the suggestion which useful for :

- this research can be a reference for students of English department to learn more about the type of hate speech and illocutionary act.
- otherwise who wanted to make as reference for the further research to analysed the types of hate speech and illocutionary act. this research could help the further writer to know and understand types of hate speech ad illocutionary act.
- 3. the researcher hopes the result f the research can help teacher get the source of scientific research in this area.

4. the researcher hopes this research can help other researcher or readers text mentors or references to do the same research but with different point of view.
