ABSTRACT

This study deals with the analysis of Speech Act in Donald Trump's Speech in The presidential Candidacy. The objectives of this study were to describe the types of speech act in Donald Trump's Speech in The Presidential Candidacy. to realization types of speech act that found in Donald Trump's Speech. to analyze reasons Donald Trump used speech act. Descriptive qualitative method was used in this study. Source of data was obtained from Transcription Donald Trump's Speech, 100% of the 9 pages was taken as the sample of data. In collecting the data, the researcher Downloading Transcription Donald Trump's Speech From Internet, Reading transcript Donald Trump's Speech, Underlining the speech acts found in Script Donald Trump's Speech, Analyzing the meaning of each speech act that found. Identifying each types of Speech Act. The data were analyzed in some steps, Classifying the data on the types of speech acts, Describing the data on the types of speech acts, calculating the percentage of the types of speech acts, Drawing the conclusion of the data. The finding showed the occurrences four types of speech act in *Donald Trump's Speech* in the Presidential Candidacy, they were 213 assertive or 77.8%, 9 directive or 3.2%, 51 commisive or 18.5%, 2 expressive or 0.72%, the reasons of performing speech acts viewed from the context of situation included making his speech attractive, giving an emphasis on a certain issue, showing optimism, building rapport to the audience, showing his seriousness to the audience that could bring america into better nation, and showing his dislike to muslim.

CHAPTER I

INTRODUCTION

A. Background of the Study

politician language deals with the use of power to organize people's mind and opinion. it is an instrument used to control the society in general. speech heard by a lot of people, every person has different interpretations that can influence the candidates. political speech can be seen as a means of establishing and maintaining social relationships, expressing feeling, and selling ideas, policies and programmes in any society. in pragmatics aspect, this means speech act theory speech act performed by particular word often depends on the speaker's intention and the context in which the word uttered.

As stated by Austin (1962), there are three types of acts that can be performed by every utterance, given in the right circumtances: (1). Locutionary, which is the act of actually uttering sentences or utterances. (2). Illocutionary, which is the act that is performed in saying something. This is when the speaker shows his or her intantion in speaking. (3). Perlocutionary, which is the act by saying something in particular context. Perlocution is a respond from the hearer. A respond is not only in foem of reply utterence but also in form of understanding action. According to Searle (1979:12-17), illocutionary act is used to accomplish some communicative purpose, such as asking, ordering, suggesting, requesting, informing, advising, greeting. He said that there are five categories of utterance found in illocutionary act. They are assertive, directive, commisive, expressive, and declarative. Futhermore, he explains that an assertive is an illocutionary act which is influenced by the speaker's belief, directive is an illocutionary act where the speaker wants the hearer to do or not to do somethig, commisive is an illocutionary act which commits the speaker to do the action in the future, expressive is an illocutionary act that expresses his feelings about an event, and declaration is an illocutionary act which is uttered by the speaker to change the state of affairs in the world.

In communication, context is important because context is needed to help the hearer to understand the speaker's intention. As Leech (1983: 13) explains, context is "any background knowledge assumed to be shared by S (speaker) and H (hearer) which contributes to H's interpretation of what S means by given an utterance". It means that to be able to understand what the speaker say, the hearer must have the same background knowledge with the speaker which is, the context. Without context, the hearer will find difficulity in interpreting the meaning of the speaker's utterance. When there is no context, the commucation between the speaker and the hearaer will fail. The hearer may be confused or misunderstand the speaker's intention. And also lack to understand types of speech act. In the speech, the speakers highly expect that the hearers understand speakers' intention. In fact, the speaker use utterances with the implied meaning. So that, hearer have difficulity in interpreting what are being said and often misunderstand and the commucation between the speaker and the hearer will fail.

In Donald Trump's speech the researcher observes that there are so many utterances that are use by Donald Trump. The utterance related to the speech action and speech event. These utterances relate tp speech acts include locutionary acts, illocutionary acts and perlocutionary acts. There were types of speech acts in this speech that is the reason why speech act is choosen to be analyzed. There are analyzed based context, emotion, and feeling.

Based on the explanation above, the researcher is interested to do a research entitled "Speech Act in *Donald Trump's Speech* in the Presidential Candidacy"

B. The Identification of Problem

Related to the background above, the problems were identified below:

- 1. The readers were lack to understand the types of speech act.
- 2. Some people were still confused to understand speech act.

C. Scope and Limitation

This study is limited to dealing with the speech act which is also the illocutionary act.

- 1. What types of speech acts are performed by Donald Trump in his speech?
- 2. How is the speech act that found in Donald Trump's speech?
- 3. Why does Donald Trump perform the speech acts?

E. The Objective of The Study

CHAPTER II

THE REVIEW OF LITERATURE

A. Theoretical Framework

1. Pragmatics

Pragmatics is another branch of linguistics that is concerned with meaning. The meaning itself comes from the context when someone utter words, phrases or sentences. The speaker has some factors that make their utterance be sense. There are many definitions about pragmatics from some linguists. Levinson (1983:24) defined pragmatics as the study of the ability of language to pair sentences with the context in which they would be appropriate. It means that both of hearer and speaker must have skill to catch the appropriate meaning of sentence the certain context.

According to Yule (1996:9) defined pragmatics as the study of contextual meaning. Pragmatics is concerned with the study of meaning as communicated by a speaker (or a writer) and interpreted by a listener (or a reader). So that, it involves the interpretation what people mean in a particular context and how the context influences what is said. And also Yule (1996:127) said when we read or hear a piece of language. We normally try to understand not only what the words mean, but what the writer or speaker of those words intended to convey. Furthermore, Yule (1996:3) divided three areas in which pragmatics are concerned. Firstly, pragmatics is the study of meaning. In means that pragmatics

focus on everything which the speaker communicated and if the hear can interpret the utterance of the speaker. Secondly, pragmatics is the study of contextual meaning. When the speaker want to say something, they must consider to organize whom, when, where they are talking. Third, pragmatics is the study of how to get communication than what is said. Pragmatics is related with what is unsaid by the speaker.

Pragmatics is the study of the relation between language and context that is the basic account of language understanding (Leech, 1983:10). Thus, Yule (1996:4) stated the speaker or the writer must be able to depend on a lot of shared assumptions and expectations. Pragmatics concerns to people's assumptions, people's purpose or goals, and the types of actions (such as request, offer, apologize, etc.) that they are performing when they speak.

In reference to the defenition of pragmatics stated by some experts above, it can be summarized that pragmatics is the study of the speaker's intended meaning related to its context. It deals with how eople use language within a context and why they use language in a particular way.

2. The Goal of Pragmatics

Akmajian (2010:363) summarized that minimal requirement of an adequate pragmatics theory as follows:

- a. A pragmatics theory must contain classification of speech acts
- b. A pragmatics theory must contain analysis and definition of various speech acts must contained

- c. A pragmatics theory must contain specification various use of various speech acts.
- d. A pragmatics theory must contain related and direct language use to such phenomena a follows:
 - 1. Linguistic structure (semantics, syntax, and phonology)
 - The structure of communication, the course of conversation and social institutions.
 - 3. Speaker meaning, implication, persupposition and understanding.

Pragmatics deals with utterance, by which we are mean specific events, the intentional acts of speakers at time and places, typically involving language and sometimes character as dealing with the effect of context. The facts with which pragmatics deals are various sorts, including:

- 1. Facts about the objective facts of the utterance, including: who the speakers is, when the utterance occured and where.
- Facts about the speakers' intentions. On the near side, what meaning is intended to be using, whom he intends to refer to with various shared names. On the far side, what he intends to achieve by saying what he does.
- 3. Facts about beliefs of the speaker and those to whom he speaker and the conversation they are engages in, what beliefs do they share, what is the focus of the conversation, what are they talking about.

4. Fact about relevant social institutions, such as promising, marriage, ceremonies, courtroom procedure, and the like, which effect what a person accomplishes in or by saying what he does.

3. Speech Acts

The uttarances produced by the speakers often carry actions such as to inform, to express feeling and ect. This is often called speech acts. With regard to speech acts, the followings present the defenition and categorization of speech acts.

Speech acts have become important issues in the field of linguistics. There are many linguisticts who have provided different defenitions of speech acts. The term speech act was initiated by Austin (1962) and developed by Searle. According to Austin, a speech act is an act performed when someone says something. Moreover, he classifies the speech acts into locutionary, illocutionary, and perlocutionary acts.in line with Austin (1962) state that speech acts are actions carrird out through language.

Another defenition is presented by Nunan (1993). According to him, speech acts are things people do through language for instance apologizing, complaining, instructing, agreeing, and warning. Furthemore, Yule (1996) says that actions performed via utterances are often called speech acts.

The next defenition is proposed by Aitchison (2003) who states that speech act is a number of utterance functioning like actions. Moreover, she says that when someone utters a sequence of words, they are trying to achieve some effects from those words. In summary, speech acts are utterances that replace actions for particular goals in certain situations.

Some linguistist offer different categorizations of speech acts. There are three categorizations of speech acts in reference to Astin (1962), Searle (1969) and Leech (1983). Each is presented below.

3.1 Austin's Categorization of Speech Acts.

Autin (1962) proposes three different types of speech acts. They consist of locutionary, illocutionary and perlocutionary. Locutionary act is uttering certain utterances with particular sense and reference, which is roughly equivalent to meaning in the traditional sense (Aunstin, 1962). In other words, locutionary acts perform the acts of saying something. Moreover, leech (1996) makes a formula for this act into: s says to h that X. In this formula, s refers to the speaker, h refers to the hearer, and X refers to the words spoken with a certain sense and reference.

Another defenition is presented by Yule (1996). He states that this type of act is the basic act of utterances to produce meaningful linguistic expressions. Similarly, cutting (2002) defines locutionary acts into whay is said or the form pf the words spoken. Locutionary acts can be classified in three types based on how english sentences are cinstructed. They include declarative, imperetive and interogative. Each has the idea of telling something, giving an order, and asking a question respectively (Ustin, 1962).

The second type of speech acts according to Austin (1962) is illocutionary acts. This is the act of informing, ordering, warning, undertaking and

etc. According to Austin (1962), illocutionary acts is an utterance which has a particular conventional force. In other words, illocutionary acts refers to what one does in saying something. This act can be formulated into: in saying X, s asserts that P in which P refers to the proposition or basic meaning of an utterance (Leech, 1996). With regard to this kind of act, Yule (1996) gives an example "I've just made some coffee". In saying that utterance, the speaker makes an offer or a statement. Austin divides illocutionary acts into five main types. Verdictives, Exercitives, Commisives, Behabities and Expositives.

3.2 Searle's Categirization of Speech Acts

The classification of speech acts is presented differently by Searle (2005). According to Searle (2005) someone perform three different acts when they are speaking, nemely utterance acts, propositional acts, and illocutionary acts. Utterance acts refers to uttering collection of words. Meanwhile, propositional acts and illocutionary acts deal with uttering words in sentences in certain context, under certain conditions, and with certain intentions. Searle (2005) divides illocutionary acts into five main types, there are: Representative, directives, commisives, expressive, declarative.

3.3 Leech's Categorization of Speech Acts

Another categorization of speech acts is presentes by Leech (1996). Leech (1996) says that the functions of illocutionary rely on how utterances relate to the socialgoal of establis heing and maintaining community, in this case, speech acts

are categorized into four types, namely competitive, convival, collaborative and conflictive.

The first kind of speech acts is comperatitive. In this type of speech act. The goal of the illocutionary compete with the social goals. This speech act function to show politeness in the form of negative parameter. The important point regarding this act is reducing the discord in the competition between what the speakers want to again and what 'good menner'is ordering, asking, demanding, begging, and requesting are the examples of this kind of speech act.

The second type of speech acts is convivial. The illocutionary goals in convivial acts are related to the social goals. In contrast to competitive acts, convivial is intrinsically courteous. This means that politeness is in the positive form of seeking opportulating are the examples of this type of speech acts.

The next type of speech acts is collaborative. It has the idea that the illocutionary goals are different from the social goals. N this case, politeness and impoliteness are relevent. This is found in most of written discourse. Asserting, reporting, announcing, and instructing belong to this type of speech acts.

The last type of speech acts is conflictive. This act suggests that be illocutionary goals conflict with the social goals. With regard to this, politeness does not need to be requested because the term in this illocutionary function are used to cause offence or hurt the hearer's feeling. Threatening, accusing, cursing, and reprimanding are included as the examples of the comflictive.

4. Types of Speech Act

In linguistic communication, people do not merely exchange information. They actually do something through talking or writing in various circumtance. Action performed via speaking is called speech act.

4.1 Locutionary Acts

According to Austin, locutionary acts is acts of speaking, acts involved in the construction of speech. Such as uttering certain sounds or making certain marks, using particular words and using them in conformity with the grammatical rules of a particular language and with certain references as determined by the rules of the language from which they are drawn. Locution is the actual words that are uttered. Austin (1975:109), also explaned first awakened wide interest in speech acts, included the act of referring as part of the locutionary act, and they were first separated by Searle in speech acts (1969:81) whereas locution are defined on a particular language, reference is defined on particular worlds.

Examples:

(1) Angklung is the traditional music tool from Indonesia.

(a statement to inform traditional music tool of Indonesia)

(2) China has many people

(a statement about the population in China)

4.2 Illocutionary Acts

Illocutionary acts is an act performed in saying something. It is something that the speaker intend to do in making utterance. It is performed within the full control of the speaker and it is evident after the utterance is made.

Examples:

(3) *Open the windows please*

(a statement about ordering to do something)

(4) Where does he go

(a statement about asking someone)

Akmajian (2010:396) pointed out that there are some characteristic of illocutionary act:

- a. Illocutionary act can often be successfully performed simply by uttering the tight explicit performative sentence, with the right intention and beliefs and under the right circumtance.
- b. Illocutionary act are central to linguitics communication. The normal conversation is composed in the right part of statement, request, order, thank, ask, and the like. The performed act of persuding, one does so by performing illocutionary act of stating or informing.
- c. Most illocutionary act which used to communicate has the feature that one perform them successfully, simply by getting one's illocutionary intention recognized. For example, when someone says, "I'm thirsty", which means that the speaker wants the listener to give him a glass of

water. His illocutionary intention will be recognized if the listener responds it by giving a glass of water to the speaker. Than will be successfully tell the listener his intention.

4.2.1 The types of illocutonary Acts.

Searle (1975) has set up the following classification of illocutionary speech acts, they are:

a. Representative (Assertive)

are the point or purpose of the members of the representative class is to commit the speaker (in varying degrees) to something's being the case, to the truth of the expressed proposition. All of the member of the representative class are assessable on the dimention of assessment which includes true and false. Representative can be uttered in a form of affirming, stating, asserting, believing, concluding, conveying, boasting, denying, describing, informing, predicting, claiming, complaining, and suggesting.

 Charles Darnay ;" actually sir, I believe it's only your bed luck that has kept me out of prison in france." (the utterance of Charles Darnay performs representative of believing)

b. Directives

are the illocutionary point of these consists in the fact that they are attempts (of varying degrees, and hence, more precisely, they are determines of the determinable which includes attempting) by the speaker to get the the hearer to do something, e.g. ordering, commanding, requesting, asking, praying, inviting, permiting, advising, recommanding and warning.

(2) "when was it passed ?" (the utterance of speaker performs about asking).

c. Commisive

are those illocutionary acts whose point is to commit the speaker (again in varying degrees) to some futute course of action, e.g. promising, offering, and vowing.

(3) "I will listen to you, I will be glad to, if it makes your happier. (the utterance of speaker perform about promising)

d. Expressive

are the illocutionary point of this class is to express the psychological state specified in the sincerity condition about a state of affairs specified in the propositinal content, e.g. thanking, congratulation, pardoning, blambing, condoling, praising, whishes and greetings.

- (4) Thank you very much, sir (the utterance of speaker about thanking)
- (5) Congratulate you that you won the race nor (a statement about congratulation).

e. Declarative

are defining characteristic of this class that the succesful performance of one of its members brings about the correspondence between the propositional content corresponds to the word, e.g. appointing, blessing, cursing, disaproving, bidding, firing, form employment, dismissing, excommunicating, naming, nominating, and resigning.

(6) Oke please, go ahead from my office. Don't you back work again here!(the atterance of speaker perform declarative of dismissing).

4.2.2 Illocutionary force Indicating Device (IFID)

Defining illocutionary forces is a difficult task, and previous sections give a hint why. On the one hand, qua an illocutionary act an utterance is something more that a sentence endowed with a propositional content (and a certain mode of presentation and/or an illocutionary potential), but on the other hand, illocutionary acts are not perlocutions.

Austin famously attempted to draw the perlocutions/illocutions divide with the help of conventionality; while the effects of perlocutionary acts belong to the realm of physical causation, the effects that the endows an utterance with its illocutionary force - the uptake – is only conventional. This appeal to conventions was criticized by strawson (1964) on the grounds that while the successful performance of illocutionary acts such as bidding five no trumps depends on the interlocutor's awarencess of certain conventions being in force, in order to recognize that an utterance is, for instance, a warning, one does not need any convention. Following strawson's lead, illocutionary acts are often divided into institutional illocutionary acts whose study requires to take into account instra cultural conventions and non institutional illocutionary acts whose analysis can be laid out in general, cross linguistic and cross-culural terms.

According to strawson (1964-1197), illocutionary forces bellonging to the second, non institutional catergory must be analyzed. A speaker performed an illocutionary act, if and only if

- a. The speaker has the intention (i1) to produce a certain effect on the addressee
- b. The speaker has the intention (i2) that the addressee recognizes i1
- c. The spreaker has the intention (i3) that the recognition of i2 causes the satisfaction of i1 and
- d. The speaker has the intention (i4) that the addressee recognizes i3.

In short, a locutionary act would constitute an illocutionary act if, and only if, form is performance, the addressee can infer that the speaker had complex intentions of the kind of *i*1-*i*4, Bach and Harnis(1979:1197) provided a systemtic account of speech act interpretation in these inferential terms.

One way to avoid the confusion between illocutionary and perlocutionary acts is to get back to conventionas. Serle (1969:1198) thus clainms that the literal, that is, conventional , meaning of sentence type is he direct and literal illocutionary act to which the uterance of this sentence corresponds, in other words, to know te linguistic meaning. There are two questionable consequences to this view, which i shall only mention. Firs, one has to endorse Searle's Expressibility Principle, or same varient of it, which states that every illocutionary act can be expressed literally. Because Searle's position is also that any illocutionary act can take any proposition as content, it follow that every proposition can be expressed literally, the philosopical problems surrounding such a claim are considerable. Second, because according to Searle, the literal meaning of a sentece is the illocutionary act performed by way of uttering this sentence, and that this literal meaning is also the linguistic meaning of the sentence, we have to assume (i) that the utternce of a sentence is always, at the literal level. The performace of an illocutionary act (even if the utterance is ironical), (ii) that the literal meaning of any sentence (token) is indepedent from the context.

Finally, it is important to point out that the nation of convention used bt Searle is perhaps too rigid. According to Searle (1969), conventions conform to the formula in *C*, *X* counts as *Y*. With illocutionary forces, the situation would be the following. Producing certain sound (*X*) in a context where a these sound correspond to the language L both interlocutora use (*C*) counts, by virtue of the conventions governing the use of L, as a certain illocutionary eact (*Y*). Such a view implies that recognising a sequence of sounds as belonging to a certain language automatically endows this requence with an illocutuonary force. We have already seen in the former section that if the locutionary/ilocutionary distinction is justified, it is precisely because some of our utterance have no illocutionary force besides, illocutionary force are cancellable. Take (1) for instance.

(7) I'II come to your party

In most circumtances, (1) will be interpreted as a promise that is, as commiting the speaker to come to the hearer's party. Such a speech act does not seem indirect or non literal. Yet, yhis promissorry or commisive force does not belong to the conventional meaning of (1) for instance, it can clearly be cancelled.

(8) I'II come to your party. I can't promise through.

Conventions, and more especially conventions that govern our use of language, can be thought of in more flexible terms. A convention is just a pattern of activity that keeps being reproduced, because it triggers certain effects often enough for this reproduction to take place. In such terms, saying that a certain sentence has conventionally a certain illocutionary force does not mean that it cannot be used without his force, but that its having this illocutionary forcehas been rebust enough to ensure that speakers continue to use it. To be sue, it remains to be shown how conventionally having an illocutionary force can be analyzing without assimilating this conventional function to the production of certain perlocutionary effects.

4.3 Perlocutionary Act

Perlocutionary act is an utterance with a function intending it o have an effect. It is performed by saying something that produces effects to the hearer. Cruse(2000:332) said that perlocutionary acts are acts performed by means of language using language as toll. The elements which define the act are external to

the locutionary act. Take the act of persuading someone to do something, or getting them to believe that something is the case.

The perlocutionary is hearer's behavioral response to the meaning of utterance not necessary a physical or verbal respons, perhaps merely by a mental or emotional response of some kinds. Other perlocutionay acts are such as thing as : alerting hearer of danger, persuading hearer to an opinion by stating supporting facts, intimidating heare by warning hearer of danger, persuading hearer to an opinion by stating supporting facts; intimidating hearer to an opinion by stating supporting facts; intimidating hearer to do something by means of a suggestion, a hint, a request or a command and so forth.

5. Context

Context belong to important aspect in pragmatics since pragmatics deals with the meaning of words in context or interaction and how the persons involved in the interaction. According to Nunan (1993), context is the situation giving rise to the discourse is embedded. Context can be divided into two types. They include linguistic and non-linguistics context. Linguistics context refer to the language that surrounds a part of discourse being analyzed meanwhile non linguistic context are related to the discourse within. Non-linguistics context may consist of communication types, topic, pusposes, settings, participant, and shared background knowledge of a certaint event. Also, context can be classified into context of situation and context of sosial cultural they are explain below.

5.1 Context of Situation

Context of situation plays an important role in communication. It refers to what speakers know about what they can see around them (Cutting, 2002). In addition, Hymes in Wardhaugh (1986) state that there are many factors involved in speaking. They are describe are ethnography of a communicative event which is relevant with understanding how a particular communicative event achieves its objectives. The first factor is setting and scene (s). setting deals with the time and place. In other words, it has something to do with the concrete physical circumstances in which a speech occurs. Meanwhile, scene is the absract psychological setting. The example of setting and scene is a graduation speech will have a joyful scene whereas the inaugural speech of USA president will have a serious one within a certain setting.

The second factor is participant (P). This enables many different combinations between speakers and listeners. Addressers and addressees, or senders and receivers. Generally, they meet particular socially specified roles for instance teacher and students, doctors and patients, parents and children and the like. The third factor is Ends (E). This deals with the conventionally recognized and expected outcomes of an exchange. Also, it is related to the personal goals that participants pursua to accomplish on certain events e.g. in a courtroom, each person has person goals to achieve since the court process involve many participants such as the jury, the judge, the prosecutor, the witness, the accused, and the defense. The fourth factor is Act of sequence (A). This deals with the actual form and content of what is said. This may include how precise the words are used, how the words are used, and how the relationship between that is said and the actual topic being discussed is. For instance: in a public lecture, each participant has their own sense of act sequence to follow the system of language and things discussed within. The fifth factor is Key (K). It include the tone, manner, or spirit in which a certain message is delivered e.g. serious, humorous, sarcastic, light-hearted, gesture, posture, and event development. The sixth factor is instrumentalities (I). Instrumentalities are related to the choice of channel. For example oral, written, telegraphic and the actua l form of speech employyed such as the language, code, dialect or register.

The next factor is Norms of interaction and interpratation (N). This refers to specific behaviour and properties that attacth to speaking and also to how these may be viewed by someone who does not share them e.g. londness, silence, gaze raturn, and the like. The last factor is Genre (G) it is clearly a demarcated type of utterices. This includes poems, proverbs, riddles, sermons, lectures, prayers and etc. The are different from casual speeches for instance church services to conduct sermons, colleges public lectures, poems reading and etc.

In relation to comtext, Holmes (1992) states that contexts should be viewed from several relevant and helpful factors. Holmes (1992) adds that linguistic choices generally reflect the influence of one or more on the following: (1) the participants. (2) the setting or social context of the interaction. (3) the topic being talked and (4) the fuction of speaking.

5.2 Context of Socio Cultural

Another type of context is socio-cultural context. This influences the linguistics choices of he speakers. With regard to this, Malinowski in Halliday and Hasan (1986) says that the context of the cultural refers to the institutional and ideological background which provides value and constains an interpretation for instance, one say X may not be concidered as rude in a particular groups of conversiation but X may not considered as rude in another group of conversiation because both groups of conversiation may have different cultures.

Any linguistic interaction the whole cultural history of thr participant and the kind of practices they engage in the short, it is not sufficient if people only take into account the context of situation and ignore the cultural context.

6. Speech

Speech is the vocalized form of communication based upon the syntactic combination of lexicals and names that are drawn from very large (usually about 1,000 different words) vocabularies. Each spoken word is created out of the phonetic combination of a limited set of vowel and consonant speech sound units (phonemes). These vocabularies, the syntax which structures them, and their sets of speech sound units differ, creating many thousands of different, and mutually unintelligible, human languages. Most human speakers are able to communicate in two or more of them, hence being polyglots. The vocal abilities that enable humans to produce speech also enable them to sing.

A gestural form of human communication exists for the deaf in the form of sign language. Speech in some cultures has become the basis of a written language, often one that differs in its vocabulary, syntax and phonetics from its associated spoken one, a situation called diglossia. In addition to its use in communication, it is suggested by some psychologists such as Vygotsky that speech is internally used in mental processes to enhance and organize cognition in the form of an interior monologue.

Speech is researched in terms of the speech production and speech perception of the sounds used in vocal language. Other research topics concern speech repetition, the ability to map heard spoken words into the vocalizations needed to recreate them, which plays a key role in vocabulary expansion in children and speech errors. Several academic disciplines study these; including acoustics, psychology, speech pathology, linguistics, cognitive science, communication studies, otolaryngology and computer science. Another area of research is how the human brain in its different areas such as the Broca's area and Wernicke's area underlies speech.

It is controversial how far human speech is unique; in that animals also communicate with vocalizations. While none in the wild have compatibly large vocabularies, research upon the nonverbal abilities of language trained apes such as Washoe and Kanzi raises the possibility that they might have these capabilities. The origins of speech are unknown and subject to much debate and speculation.

7. Language of Politics

Language is widely used in the field of politics to persuade and influence people. According to Joseph (2006), language reflects the speaker's intelligence, industry, and sosial worthiness level of exposure or education. Interpreting language use in this way belong to a political act. The power and responsibility of the speakers can be reflected from the linguistic political dimension that utilizes language to achieve their goals.

In relation to politics, Thomas (2004) states that politics deals with power including the power of making decisions, controlling resources, controling other people's behavior and often controlling their values. Politics cannot be separated from power. The power acquisition and political beliefs enforcement can be gained using some strategies, namely through physical coercion or legal system. The physical coercion events that are regarded as significant in history involve the imposition, military rules, dictatorial regimes, and the like. Some types of coercions are also implemented in a democracy though the legal system e.g. there are laws which regulate where people are supposed to litter, laws on the prohibition of destroying others belogings, and the laws that rule where and when people can drimk alcohol legally. If some breaks these laws. They will be fined, arrested and imprisoned. They are example of politcal end gained by coercions.

In order to secure power, it is necessary to persuade and convince everyone that what you want to achieve is the same as what they want.with regard to this, an ideology needs to be established i.e. the ideology that makes te beliefs
which you want people to hold appear to be common sense. Therefore it makes difficuls for them to question that dominant ideology.

8. The profile of Donald Trump

Donald John Trump Sr. (born June 14, 1946) is an American business magnate, investor, television personality and author. He is the chairman and president of The Trump Organization and the founder of Trump Entertainment Resorts. Trump's extravagant lifestyle, outspoken manner, and role on the NBC reality show The Apprentice have made him a well-known celebrity who was No. 17 on the 2011 Forbes Celebrity 100 list.

Trump is the son of Fred Trump, a wealthy New York City real-estate developer. He worked for his father's firm, Elizabeth Trump & Son, while attending the Wharton School of the University of Pennsylvania, and in 1968 officially joined the company. He was given control of the company in 1971 and renamed it The Trump Organization.

In 2010, Trump expressed an interest in becoming a candidate for President of the United States in the 2012 election, though in May 2011, he announced he would not run. Trump was a featured speaker at the 2013 Conservative Political Action Conference (CPAC). In 2013, Trump spent over \$1 million to research a possible run for President of the United States in 2016.Trump is expected to make a formal announcement on whether he will run for President of the united states on june 16, 2015.

B. Relevant studies

There some studies that related to this research had been conducted before. The first study is conducted in the proposal by Meida Yusmalinda. On her title proposal entitle: *Performative Utterance in Muhammad the Messenger of Allah Biography*. This study is shown the research about performative and used random sampling teqnique and researcher tool 50% to be sample. And the found a book of biography Muhammad and analyzed the content of biography.

The second related is conducted in the journal by Anda Ryan Syah, Sriti Usman, Siska Bochari on their title journal entitle: *Analysis of illocutionary act of Command By The main Character in Despicable Me Film*. They are classified the data into two tables based on the forms of sentence. The writer found that there were teo form of sentence in command that were uttered by the main character in Despicable Me Film. They were imperative and declarative form of sentence. What makes this research different from the first and second previous is in this research the researcher analyzing more specific of utterance and conducting from subtitle; *Speech act in Donald Trump's Speech in The presidential Candidacy*.

C. Conceptual Framework

Pragmatics is the study of language in a human context of use. Language use is the process by which people comunicate for various purposes, using linguistics mean. This process is influenced by the conditions of society, in as much these conditions establish the user's access to end control of those means. Than, pragmatics can also be described as a societally oriented and societally bound linguistics.

Speech act is studied in some interdisciplinary studied, such as: pragmatic, sociolinguistic and so on. But, it is viewed from different point with discussion each them. Pragmatic focuses on the meaning of context which hppened between a speaker and hearer in communication or concerns on the meaning of utterances in speech.

The researcher belive that tere are speech acts in Donald Trump's speech, and it must be discovered do that can be found the real meaning and get the point and understood by the readers. And than in this research the researcher chooses Searle's illocutionary acts.

In this research used descriptive qualitative method, the researcher classifying the utterances into the Searle's categories of illocutionary acts and calculating the percentage of the Searle's categories of illocutionary acts.

CHAPTER III

METHOD OF RESEARCH

A. Research Design

In conducting this research, the qualitative documentary method will be use. The data consists of words. Flick (2009:21) says that qualitative research is oriented toward analyzing concrete cases in their temporal and local particularly and starting for people's expression and their local content. It meant that analyzing expression based on the context and situation is a important section that used during this research.

By using descriptive qualitative method, this research tried to describe the speech acts which explain in the speech. Therefore, the researcher collected the data, analyzed and interpreted the various forms of speech act.

B. Source of Data

The source of data this research was transcription of *Donald Trump's Speech*. Consisting of 9 pages. The speech was published by Politico Staff.

Used sensus sampling technique. Was used in this study From 9 pages, the researcher take 100 % to be the sample. The pages used, it is a full transcription of the speech.

C. Techniques for Collecting Data

There were some steps in collecting the data. The steps were as follows:

- 1. Downloading Transcript *Donald Trump's Speech* From Internet.
- 2. Reading transcript Donald Trump's Speech.
- 3. Underlining the speech acts found in Transcript *Donald Trump's Speech*.
- 4. Analyzing the meaning of each speech act that found.
- 5. Identifying each types of speech acts.

D. The Technique of Data Analysis

The data were analyzed by using descriptive technique. In this technique,

the data was analyzed in term of the qualitative analysis. The steps were as follows:

- 1. Classifying the data on the types of speech acts.
- 2. Describing the data on the types of speech acts.
- 3. Calculating the percentage of the types of speech acts.
- 4. Drawing the conclusion of the data.

CHAPTER IV

DATA AND DATA ANALYSIS

A. Data

There were 275 data was found in the Donald Trump's Speech in the Presidential Candidacy, Nov. 9, 2016. (see appendix)

The finding show that all types of speech act are employed in Donald Trump's speech. Dividing speech act into four types, assertive, directive, commisive, expressive.

a. Assertive

Assertive is an illocutionary act that represents a state of affairs. E.g. informing, denying, stating, asserting, predicting, announcing, conjecturing and disagreeing. There were 213 utterances found in Donald trump's speech in the Presidential Candidacy.

For example:

- But here, at our convention, there will be no lies. (stating, data no 20)
- Decades of progress made in bringing down crime are now being reversed by this Administration's rollback of criminal enforcement. (informing, Data no 23)
- 3. In 2009, pre-Hillary, ISIS was not even on the map. (informing, data no 55)

b. Directive

Directive is an illocutionary act for getting the addressee to do something. E.g. ordering, asking, commanding, daring, defying, challenging. There were 9 utterances found in Donald Trump's speech in the presidential Candidacy.

For example:

1. What about our economy?

(asking, data no 34)

Yet, what do we have to show for it?
 (aksing, data no 42)

3. Now let us consider the state of affairs abroad.

(inviting, data no 44)

c. Commisive

Commisive is an illocutionary act for getting the speaker (i.e. the one performing the speech act) to do something. E.g. promising, threatening, intending, vowing to do or to refrain from doing something. There were 51 utterance found in *Donald Trump's Speech* in The Presidential Candidacy.

For example:

- we will lead our country back to safety, prosperity, and peace (promise, data no 4)
- 2. Beginning on January 20th 2017, safety will be restored.(promise, data no 13)
- On the economy, I will outline reforms to add millions of new jobs and trillions in new wealth that can be used to rebuild America.
 (promise, data no 77)

d. Expressive

Expressive is an illocutionary act that expresses the mental state of the speaker about an event presumed to be true. E.g. congratulating, thanking, deploring, condoling, welcoming, apologizing. There were 2 utterance found in *Donald Trump's speech* in the Presidential Candidacy.

For example:

1. Friends, delegates and fellow Americans

(greeting, data no 1)

2. I humbly and gratefully accept your nomination for the presidency of the United States.
(thanking, data no 2)

C. Research Finding and discassion

After analyzing the data were obtained from *Donald Trump's Speech*, The finding were there were four types of speech act used in *Donald Trump's Speech* namely assertive, directive, commissive, expressive, the types of speech act found in *Donald Trump's Speech* was 275 utterances included Assertive 77.8% in 214 act, directive 3.2% in 9 act, commisive 18.5% in 51 act, and expressive 0.72% in 2 act.

And the weakness this research is not all of types speech act there are in the data, but the data easy to analyzing because the content many about information and promise, but sometimes laguage in the data difficulity to comprehend because used implied meaning. this study is conducted in the proposal by Meida Yusmalinda. On her title proposal entitle: *Performative Utterance in Muhammad the Messenger of Allah Biography*. But different object this research the object in speech and Meida Yusmalinda's proposal in Biography.

CHAPTER V

CONCLUTIONS AND SUGGESTIONS

A. Conclutions

After analyzing the data, conclutions are drawn as the following.

- There are four types of speech act found in this research, namely Assertive, directive, commisive, expressive. There are 275 Illocutionary act found in Donald Trump's Speech, include fourth types of Illocutionary act. Namely Assertive there were 214 or 77.8%, directive there were 9 or 3.2%, commisive there were 51 or 18.5%, Expressive 2 or 0.72%.
- 2. The realization of the Speech Act in Donald Trump's speech, we look realization from form uttererances.
- 3. Viewed from the it is found the reason are, making his speech attractive, giving an emphasis on a certain issue, showing optimism, building rapport to the audience, showing his seriousness to the audience that could bring america into better nation, and showing his dislike to muslim.

So this situation can be categorized as assertive.

2. This is the legacy of Hillary Clinton: death, destruction and weakness.

From the utterance above, asserting was uttered Donald Trumps saying "This is the legacy of Hillary Clinton: death, destruction and weakness". This situation Donald Trumps give informing to american society about condition in america now, and after that Donald Trumps give assertive if all of that is legacy of Hillary Clinton. So, this is can be categorized as assertive

B. Directives

this illocutionary act attempts the addresses to do something, the speaker intended to produce some effects though action by the hearer, such us ordering (asking for somebody to do something), commanding (commanding somebody to do thing), requesting (asking something politely), advising (giving advice or opinion to somebody about what she or he) should do), recommending (suggesting or advising), asking (questions constituting a sub-class of directives). Example:

1. What about our economy?

From the utterance above, asking was uttered by Donald Trump saying "What about our economy?". In this situation donald trump explain about some facts and Donald trump ask to audience or americans society about their economy, So this is can be categorized as directives.

2. Yet, what do we have to show for it?

And after that donald trumps say what do we have to show for it to audience, So this situation can be categorized as directives.

C. Commisives

This illocutionary act is an act which the speaker commits to some future action. This point is concerned with altering the world to match the words, but this time the point is to commit the speaker her/himself to acting and it necessarily involves intention. The example of this point are promising (stating something to do next), threatenig (stating an intention to punish or harm somebody), and offering (presenting something to be accepted or refused).

Exsmple:

1. Together, we will lead our party back to the White House

This situation after Donald Trumps greeting and thanking Donld Trumps promising will be lead their party back to the white house. this is future for his party and american society. So, this is can be categirized as commisives.

D. Expressives

This illocutionary act is an act which the speaker expresses a psychological state specified in the sincerity condition about a state affairs specified in the propositional content. This point includes thanking (expressing one's gratitude to somebody), apologizing (saying sorry to somebody), welcoming (greeting somebody in a friendly way when s/he arrives), congratulating (expressing pleasure at the success or good fortunes), pardoning (acting of forgiveness), and praising (expressing a praise).

Example:

1. Friends, delegates and fellow Americans

From the utterance above, greeting was uttered by Donald Trumps say "Friends, delegates and fellow Americans". This situation Donald Trumps greeting american society when he start her speech, so this situation can be categorized as expressives.

CHAPTER V

Namely Assertive there were 214 or 77,8%, directive there were 9 or 3,2%, commisive there were 51 or 18,5%, Expressive 2 or 0,72%.
- The dominant type of Illocutionary act found in Donald Trump's Speech was Assertive namely 77,8% in 214 act.

Decades of progress made in bringing down crime are now being reversed by this Administration's rollback of criminal enforcement.

Homicides last year increased by 17% in America's fifty largest cities. That's the largest increase in 25 years. In our nation's capital, killings have risen by 50 percent. They are up nearly 60% in nearby Baltimore.

In the President's hometown of Chicago, more than 2,000 have been the victims of shootings this year alone. And more than 3,600 have been killed in the Chicago area since he took office.

I will work with, and appoint, the best prosecutors and law enforcement officials in the country to get the job done. In this race for the White House, I am the Law And Order candidate. The irresponsible rhetoric of our President, who has used the pulpit of the presidency to divide us by race and color, has made America a more dangerous environment for everyone.

This Administration has failed America's inner cities. It's failed them on education. It's failed them on jobs. It's failed them on crime. It's failed them at every level.

When I am President, I will work to ensure that all of our kids are treated equally, and protected equally.

Every action I take, I will ask myself: does this make life better for young Americans in Baltimore, Chicago, Detroit, Ferguson who have as much of a right to live out their dreams as any other child America?

To make life safe in America, we must also address the growing threats we face from outside America: we are going to defeat the barbarians of ISIS. Once again, France is the victim of brutal Islamic terrorism.

Men, women and children viciously mowed down. Lives ruined. Families ripped apart. A nation in mourning.

The damage and devastation that can be inflicted by Islamic radicals has been over and over - at the World Trade Center, at an office party in San Bernardino, at the Boston Marathon, and a military recruiting center in Chattanooga, Tennessee.

Only weeks ago, in Orlando, Florida, 49 wonderful Americans were savagely murdered by an Islamic terrorist. This time, the terrorist targeted our LGBT community. As your President, I will do everything in my power to protect our LGBT citizens from the violence and oppression of a hateful foreign ideology. To protect us from terrorism, we need to focus on three things.

We must have the best intelligence gathering operation in the world. We must abandon the failed policy of nation building and regime change that Hillary Clinton pushed in Iraq, Libya, Egypt and Syria. Instead, we must work with all of our allies who share our goal of destroying ISIS and stamping out Islamic terror.

This includes working with our greatest ally in the region, the State of Israel. Lastly, we must immediately suspend immigration from any nation that has been compromised by terrorism until such time as proven vetting mechanisms have been put in place.

My opponent has called for a radical 550% increase in Syrian refugees on top of existing massive refugee flows coming into our country under President Obama. She proposes this despite the fact that there's no way to screen these refugees in order to find out who they are or where they come from. I only want to admit individuals into our country who will support our values and love our people.

Anyone who endorses violence, hatred or oppression is not welcome in our country and never will be.

Decades of record immigration have produced lower wages and higher unemployment for our citizens, especially for African-American and Latino workers. We are going to have an immigration system that works, but one that works for the American people.

On Monday, we heard from three parents whose children were killed by illegal immigrants Mary Ann Mendoza, Sabine Durden, and Jamiel Shaw. They are just three brave representatives of many thousands. Of all my travels in this country, nothing has affected me more deeply than the time I have spent with the mothers and fathers who have lost their children to violence spilling across our border.

These families have no special interests to represent them. There are no demonstrators to protest on their behalf. My opponent will never meet with them, or share in their pain. Instead, my opponent wants Sanctuary Cities. But where was sanctuary for Kate Steinle? Where was Sanctuary for the children of Mary Ann, Sabine and Jamiel? Where was sanctuary for all the other Americans who have been so brutally murdered, and who have suffered so horribly?

These wounded American families have been alone. But they are alone no longer. Tonight, this candidate and this whole nation stand in their corner to support them, to send them our love, and to pledge in their honor that we will save countless more families from suffering the same awful fate.

We are going to build a great border wall to stop illegal immigration, to stop the gangs and the violence, and to stop the drugs from pouring into our communities. I have been honored to receive the endorsement of America's Border Patrol Agents, and will work directly with them to protect the integrity of our lawful immigration system.

By ending catch-and-release on the border, we will stop the cycle of human smuggling and violence. Illegal border crossings will go down. Peace will be restored. By enforcing the rules for the millions who overstay their visas, our laws will finally receive the respect they deserve.

Tonight, I want every American whose demands for immigration security have been denied – and every politician who has denied them – to listen very closely to the words I am about to say.

On January 21st of 2017, the day after I take the oath of office, Americans will finally wake up in a country where the laws of the United States are enforced. We are going to be considerate and compassionate to everyone.

But my greatest compassion will be for our own struggling citizens. My plan is the exact opposite of the radical and dangerous immigration policy of Hillary Clinton. Americans want relief from uncontrolled immigration. Communities want relief.

Yet Hillary Clinton is proposing mass amnesty, mass immigration, and mass lawlessness. Her plan will overwhelm your schools and hospitals, further reduce your jobs and wages, and make it harder for recent immigrants to escape from poverty.

I have a different vision for our workers. It begins with a new, fair trade policy that protects our jobs and stands up to countries that cheat. It's been a signature message of my campaign

from day one, and it will be a signature feature of my presidency from the moment I take the oath of office.

I have made billions of dollars in business making deals – now I'm going to make our country rich again. I am going to turn our bad trade agreements into great ones. America has lost nearly-one third of its manufacturing jobs since 1997, following the enactment of disastrous trade deals supported by Bill and Hillary Clinton.

Remember, it was Bill Clinton who signed NAFTA, one of the worst economic deals ever made by our country.

Never again.

I am going to bring our jobs back to Ohio and to America – and I am not going to let companies move to other countries, firing their employees along the way, without consequences.

My opponent, on the other hand, has supported virtually every trade agreement that has been destroying our middle class. She supported NAFTA, and she supported China's entrance into the World Trade Organization – another one of her husband's colossal mistakes.

She supported the job killing trade deal with South Korea. She has supported the Trans-Pacific Partnership. The TPP will not only destroy our manufacturing, but it will make America subject to the rulings of foreign governments. I pledge to never sign any trade agreement that hurts our workers, or that diminishes our freedom and independence. Instead, I will make individual deals with individual countries.

No longer will we enter into these massive deals, with many countries, that are thousands of pages long – and which no one from our country even reads or understands. We are going to enforce all trade violations, including through the use of taxes and tariffs, against any country that cheats.

This includes stopping China's outrageous theft of intellectual property, along with their illegal product dumping, and their devastating currency manipulation. Our horrible trade agreements with China and many others, will be totally renegotiated. That includes renegotiating NAFTA to get a much better deal for America – and we'll walk away if we don't get the deal that we want. We are going to start building and making things again.

Next comes the reform of our tax laws, regulations and energy rules. While Hillary Clinton plans a massive tax increase, I have proposed the largest tax reduction of any candidate who has declared for the presidential race this year – Democrat or Republican. Middle-income Americans will experience profound relief, and taxes will be simplified for everyone.

America is one of the highest-taxed nations in the world. Reducing taxes will cause new companies and new jobs to come roaring back into our country. Then we are going to deal with the issue of regulation, one of the greatest job-killers of them all. Excessive regulation is costing our country as much as \$2 trillion a year, and we will end it. We are going to lift the restrictions on the production of American energy. This will produce more than \$20 trillion in job creating economic activity over the next four decades.

My opponent, on the other hand, wants to put the great miners and steel workers of our country out of work – that will never happen when I am President. With these new economic policies, trillions of dollars will start flowing into our country.

This new wealth will improve the quality of life for all Americans – We will build the roads, highways, bridges, tunnels, airports, and the railways of tomorrow. This, in turn, will create millions more jobs. We will rescue kids from failing schools by helping their parents send them to a safe school of their choice.

My opponent would rather protect education bureaucrats than serve American children. We will repeal and replace disastrous Obamacare. You will be able to choose your own doctor again. And we will fix TSA at the airports! We will completely rebuild our depleted military, and the countries that we protect, at a massive loss, will be asked to pay their fair share.

We will take care of our great Veterans like they have never been taken care of before. My opponent dismissed the VA scandal as being not widespread – one more sign of how out of touch she really is. We are going to ask every Department Head in government to provide a list of wasteful spending projects that we can eliminate in my first 100 days. The politicians have talked about it, I'm going to do it. We are also going to appoint justices to the United States Supreme Court who will uphold our laws and our Constitution.

The replacement for Justice Scalia will be a person of similar views and principles. This will be one of the most important issues decided by this election. My opponent wants to essentially abolish the 2nd amendment. I, on the other hand, received the early and strong endorsement of the National Rifle Association and will protect the right of all Americans to keep their families safe.

At this moment, I would like to thank the evangelical community who have been so good to me and so supportive. You have so much to contribute to our politics, yet our laws prevent you from speaking your minds from your own pulpits.

An amendment, pushed by Lyndon Johnson, many years ago, threatens religious institutions with a loss of their tax-exempt status if they openly advocate their political views.

I am going to work very hard to repeal that language and protect free speech for all Americans. We can accomplish these great things, and so much else – all we need to do is start believing in ourselves and in our country again. It is time to show the whole world that America Is Back – bigger, and better and stronger than ever before.

In this journey, I'm so lucky to have at my side my wife Melania and my wonderful children, Don, Ivanka, Eric, Tiffany, and Barron: you will always be my greatest source of pride and joy. My Dad, Fred Trump, was the smartest and hardest working man I ever knew. I wonder sometimes what he'd say if he were here to see this tonight.

It's because of him that I learned, from my youngest age, to respect the dignity of work and the dignity of working people. He was a guy most comfortable in the company of bricklayers, carpenters, and electricians and I have a lot of that in me also. Then there's my mother, Mary. She was strong, but also warm and fair-minded. She was a truly great mother. She was also one of the most honest and charitable people I have ever known, and a great judge of character.

To my sisters Mary Anne and Elizabeth, my brother Robert and my late brother Fred, I will always give you my love you are most special to me. I have loved my life in business.

But now, my sole and exclusive mission is to go to work for our country - to go to work for all of you. It's time to deliver a victory for the American people. But to do that, we must break free from the petty politics of the past.

America is a nation of believers, dreamers, and strivers that is being led by a group of censors, critics, and cynics.

Remember: all of the people telling you that you can't have the country you want, are the same people telling you that I wouldn't be standing here tonight. No longer can we rely on those elites in media, and politics, who will say anything to keep a rigged system in place.

Instead, we must choose to Believe In America. History is watching us now.

It's waiting to see if we will rise to the occasion, and if we will show the whole world that America is still free and independent and strong.

My opponent asks her supporters to recite a three-word loyalty pledge. It reads: "I'm With Her". I choose to recite a different pledge.

My pledge reads: "I'M WITH YOU - THE AMERICAN PEOPLE."

I am your voice.

So to every parent who dreams for their child, and every child who dreams for their future, I say these words to you tonight: I'm With You, and I will fight for you, and I will win for you.

To all Americans tonight, in all our cities and towns, I make this promise: We Will Make America Strong Again.

We Will Make America Proud Again.

We Will Make America Safe Again.

And We Will Make America Great Again.
