ABSTRACT

Ningsih, Putri Septi Ayu. 1502050050. Deixis in Sandiaga Uno's Expression in Talk Show TV Program. A Thesis. Medan. Faculty of Teacher Training and Education. University of Muhammadiyah Sumatera Utara. Medan 2019.

This study with the types of deixis in Sandiaga Uno's expression in talk show to program. The objectives of this study are to find out the types of deixis that are used by Sandiaga Uno's, to investigate the deixis used in the talk show and to reason for the use of deixis by Sandiaga Uno's expression. The data this study was the one selected video taken as the sample. The findings of this study showed that those five types of deixis were found in Sandiaga Uno's expression, they are: person 150 (63.55%), spatial 12 (5.08%), temporal 17 (7.20%), discourse 38 (16.10%), and social 19 (8.05%). The most dominant types of deixis found in Sandiaga Uno's Expression were person deixis and the deictic word "I" and "We" were the dominant deictic words that Sandiaga Uno's used in expression which interpreted that Mr. Sandiaga Uno is a firm and unobtrusive vice president.

CHAPTER I

INTRODUCTION

A. The Background of the Study

A language is a system of communication which consist of a set of sounds and written symbols which are used by the people of a particular country or region for talking writing. Text or speech is the example of written or spoken communication that is conveyed by a writer or speaker to the reader or listener which as meaning.

Deixis is a technical term comes from Greek deikitos for pointing or indicating. Deixis is an important field of language study in its own right and has some relevances to analysis of conversation and pragmatics. It essentially concerns with the ways in which languages encode or grammaticalizes the features of the context of expression or speech event, and also concerns ways in which interpretation of expression depends on the analysis of that context of expression Stephen C. Levinson (1983). There are five types of deixis, namely person deixis, spatial deixis, temporal deixis, discourse deixis and social deixis.

Person deixis concerns with the encoding of the role of participants in the speech even in which the expression in question is delivered. Spatial deixis concerns with the specification of locations to anchorage points in the speech

event. Temporal deixis that is also called as time deixis locates points or intervals on the time deixis, using the moment of expression referring to apart of the discourse. Social deixis concerns with the aspects of sentences which reflect certain realities of participants or the social situation in which the speech event occurs. By those types of deixis, we can avoid any wrong spoken communication or speaker's expression. In spoeken communication there are many ways of delivering thoughts and ideas to other people such as speech, presentation, debate, demonstartion, song and even talk show.

Talk show or chat show is a television programming or radio programming genre which one person or group of people discusses various topics put forth by a talk show host. Usually, guests consist of a group of people who a learned or who have great experience in relation to whatever issue of being discussed on the show for that episode. Other times, a single guest discusses their work or area expertise with a host or co-host. A call-in show takes live phone calls from callers listening at home, in their cars, etc. Sometimes, guests we already seated but are often introduced and enter from backstage. There have fun been many notable talk show hosts in many cases, the shows have made their hosts famous. One of them, mata najwa talk show.

When people do spoken communication include mata najwa talk show to deliver thoughts, the usage of deixis is very closely related. Every word or phrases spoken are interpreted by deixis, because it encodes features of context of expression. But everyone has the different perception of a phrase an expression. This is because the audience do not understand deixis well. So with the

explanation about the kinds of deixis we can found deixis in many kinds of media. It can be from television, newspaper, magazine and even by browsing on the internet. Mata najwa in talk show Tv Program is selected to be analyzed, because mata najwa consistently presents interesting topics with first-class speakers.

In this case, the object in this thesis will discuss the expression in deixis used of our vice president, Mr. Sandiaga Uno's expresssion in "the talk show Tv Program" the realeased on Trans7. According to the researcher herself, Sandiaga Uno is an Indonesian businessman, investor and politician who was the deputy governor of jakarta. He was elected along with Anies Baswedan in the 2017 jakarta gubernational election after defeating incumbent pair Basuki Tjahja Purnama and Djarot Saiful Hidayat. Besides, he also made a speech using english in the event ISEAS.

From these reasons above the researcher decided to create a research entitled. Deixis In Sandiaga Uno's Expression in the Talk Show Tv Program. The researcher hopes that this research will enrich the reader understanding about deixis and can help the listener or reader easily to understand the use and the meaning of deixis. And the readers to find out the types of deixis he used and how are the deixis used, especially in expression.

CHAPTER II

REVIEW OF LITERATURE

A. Theoritical Framework

A research may be on the existing theories of certain field of science in this case, the theoritical framework is aimed at giving clear concepts to application of the study. To avoid misunderstanding between the research and the reader some terms in this study are in the following.

1. Pragmatics

According to Yule (1996:3) pragmatic is concerned with the study of meaning as communicated by a speaker (or writer) and interpreted by a listener (or reader). In short, he said that pragmatics is the study of what speakers means or speaker meaning. In communication, people have to recognize the meaning of words in utterances and also what speakers or writers mean by their utterance to be able to communicated clearly.

Pragmatics is divided into four definition by (Yule 1996:3). The first definition he stated that pragmatics is the study of speaker meaning. It means that what the words or phrases in those utterances. Second pragmatics is the study of contextual meaning it is about how the speaker manage what they want to say in obedience with who they are talking to where and when the utterance is uttered. Involving the intrepretation of what people mean in a particular context and how

the context influences what is said in an essential component in this study. Third pragmatics is the study of how more gets communicated than is said. The study explore how a great deal of what is unsaid is known as part of what is communicated. It shows that how listeners can make inferences about what is said in order to arrive at an interpretation of the speakers intended meaning. The last definition pragmatics is the study expression of relative distance. The point is on the assumption of how close or distant the listener is, speaker determine how much needs to be said.

According to Cruse (2006), prgmatics is a study about aspects of meaning which are dependent on context. Furthermore, Stephen C. Levinson (1983) states that Pragmatics is a sub discipline of linguistic develop from different linguistics, philosopical and sociological traditions, which studies the relationship between natural language expression and their uses in specific situation. He said that pragmatics is study of deixis, implicative, persupption, speech acts, and aspects of discourse structure.

Based on definition above, it can be concluded that pragmatics is a subifield of linguistics which studies the ways un which context contributes to meaning. It refers to the study of those factors that govern our choices of language such as social awareness, culture and sense of etiquette. How to address a sentence to a queen, teacher, peer, and kid and how to express hospitality. There are smoe disciplines which covered in pragmatics including deixis, conversational implicature, persupposition, speech acts, and maxim.

2. Deixis

There are many words in the language that cannot be interpreted alone without being put in a context. This study discusses how to interpret the meaning of words by studying the features of deixis. Deixis means "pointing" or "showing" in Greek. Deixis important field language study in its own right and very important for learners of second languages. Deixis relates to demonstrative, first and second pronouns, tense, specific time and place adverbs like now and here, and a variety of other grammatical features which tied directly to circumstance of expression.

According to Yule (1996:9) deixis is a technical term from Greek for one of the most basic things we do with utternaces. It means 'pointing' via language. Any linguistic from used to accomplish this 'pointing' is called a deictic expression. When you notice a strange object and ask, "What's that?", you are using a deictic expression 'that' to indicate something in the immediate context. Deictic expression are also sometimes called indexicals. They are among the first forms to be spoken by very young children and can be used to indicate people via person deixis (me,you), or location via spatial deixis (here,there), or time via temporal deixis (now, then). All these expression depend, for their interpretation, on the speaker and hearer sharing the same context.

Yule (1996:9), stresses that deixis is clearly a form of refering that is tied to the speaker's context, with the most basic distinction between deictic expression being 'near speaker' versus 'away from speaker'. In English, the 'near

speaker'or proximal terms are "this", "here". The 'away from speaker' or distal terms are "that", "there". When you notice a strange object and ask, "what is that?", you are using deictic expression 'that' to indicate something in the immediate context.

Matthew (1997) describes deixis as the way in which the refrence of certain selects in a sentence is determined in relation to a specific speaker and addressee and specific time and place of utterances. Levinson (1983) defined that the meaning of deixis is 'pointing' or 'indicating' means interpretation of utterances depend on the analysis of the context of utterance. Any linguistic form used to accomplish are also sometimes called indexical.

In addition Eragbe (2015:96) describes deixis as the way in which the reference of certain elements in a sentence is determined in relation yo a specific speaker and addressee and a specific time and place of utterances. Deixis as described in many linguistic studies such as cited above are reference devices through which participants in a discourse are traced or identified; and their time and place of actions are specified. These devices help participants in a discourse to give the reader or listener the clear picture of the context in which language is used. Deixis is like refrence, with which overlaps, it relates to their context of occurrence. But deixis is both broader and narrower than reference. Refrence cam be either deictic or non deictic, and deixis does not necessarily involve refrence.

Deixis as the ways in which languages encode or grammatical features of the context of utterance or speech and thus concerns ways in which the interpretation of utterances depends on the analysis of that context of utterance. "Deixis is refrence by means of an expression whose interpretation is relative to the (usually) extralinguistic context of the utterance, such as (I) Who is speaking (2) The time or place of speaking (3) The gestures of the speaker, or (4) The current location in the discourse (Wahyudi,2004:113).

From some experts, it concluded that deixis is pointing or showing is that it determines that structure and interpretation of utterances in relation to the time and place of their occurances, the identify of the speaker and the addressee, and objects and events in the actual situation of utterances.

3. Types of Deixis

Deixis as pointing devices in discourse are categorized into different forms dending on the scholar's perspectives. Yule (2006) identify three types of deixis, they are person deixis, temporal deixis or time deixis, spatial or place deixis. Griifths (2006:14) identifies four kinds of deixis, relating to time (now, soon, recently, ago, tomorrow, next week), place (here, there, teo kilometers away, that side, this way, come, bring, upstairs), participants (person and others entities like she, her, he, him, his, they, it, that, this) and discourse itself (this sentence, the next paragraph, that was what they told me, I want you to remember this). Griffths emphasizes that our semantic knowledge of the meaning of deicti expression guides us on how, pragmatically, to interpret them in context. According to stephen C. Levinson (1983:68), there are five types of deixis. They are person deixis, spatial deixis, temporal deixis, discourse deixis, and social deixis.

3.1 Person deixis

Person deixis concerns with the encoding of the role of participant in the speech even in which the expression in question is delivered. Person deixis is related directly to grammatical categories of person. Person deixis involves basically the speaker, known as the first person, the addresse, known as the second person, and other significant participants in the speech situation, neither speaker not hearer, known as third person. Person deixis is related directly to grammatical categories of person. According to Yule (1996:10), person deixis clearly operates on a basic three-part division, exemplified by the pronouns for first person 'I', second person 'you', and third person 'he,she,or it'.

a. I watched this movie last night

The deictic word 'I' in the sentences above was first person singular.

b. Could **you** open the door, please?

The deictic word 'you' in the sentences above was second person singular because he asked one person.

c. **They** played cricket on Sunday

The deictic word 'they' in the sentence above was third person plural because it more than one person.

d. We will have fun tonight

The deictic word 'we' in the sentence above was person plural

e. I've lost the bag

The deictic word 'I' in the sentence above was first person singular.

f. She is my best friend since junior high shool

The deictic word 'she' in the sentence bove was third person singular

In the other word, person deixis refers to a person or the speaker or a person who was spoken by the speaker.

3.2. Spatial or Place Deixis

Stephen C. Levinson (1983:79) stated that place or spatial deixis concerns for the specifications of location to anchorage points in the speech event and typically the speaker, and there are two basic ways of refering objects by describing or nming them on the one hand and by locating them on the other. Alternatively, they can be deictically specified to the location of participants at the time of speaking. There are: a proximal (near the speaker) such as this, and these, and a distal (away from the speaker) such as that, and those. Each may be used either as a pronoun or in a combination with noun.

Yule (1996) states that in considering spatial deixis, it is important to remember that location from the speaker's. The other basic of spatial deictic

words in demonstratives *this* and *tha*t, although they often have more abstract meaning.

In either case it is likely that units of measurrement, or description of direction and location, will have to be used, and it that case place deixis comes to interact in complex ways with the non deictic organization of space. There are, though, some pure place deictic words, notably in English the adverbs here and ther, and the demonstrative pronouns this and that.

For example:

- a. "I will be there soon".
- b. "Here is where mother hid the gifts".

Briefly, place or spatial deixis is an expression used to show the location relative to the location of a participant in the speech event.

3.3. Temporal or Time deixis

Temporal deixis is also called as time deixis. According to stephen C. Levinson (1983:73) said that the basis for system of reckoning and measuring time in most languages seem to be the natural and promiment cycles off day and night, lunar months, season and years. Temporal deixis or time deixis is a reference to time relative to a temporal reference point and it is typically the moment expression. These language resources are the adjectives of time in the line, yesterday, now, tomorrow, and verb tense. The verb sometimes also has another function besides refering to a specific time. Furthermore, Yule (1996) says that the basic type of temporal deixis in English is in the choice of verb tense.

English only has two basic forms, the present and the past. The deictic items use

reference can only be determined in relation to the time of the utterances in which

they occur. Such as:

This/last/nest Monday/week/month/year. a.

Now, then, ago, later, soon, before. b.

Yesterday, today, tomorrow.

The present tense is the proximal form and the past is distal form. For example:

a.

Present: I live here now

b. Past : I lived there than.

So, in conclusion the researcher concludes that time deixis refers to the point of time that producted by the speaker.

3.4. Discourse deixis

Discourse deixis is any expression used to refer to earlier or forthcoming

segment of a discourse. Stephen C. Levinson (1983:85) states that discourse

deixis deals with the orientation in the text passages to the current utterances

either as a head of time or past, furthcoming or simultaneous. It encodes reference

to portions of the unfolding discourse in which the utterance is located. It means

that discourse relative to the speaker's current location in the discourse, such as:

above, below, last, previous, proceding, next or following (usually used in texts)

and this, that, next, last (usually used in utterances).

In discourse deixis, there are many words and phrase in English that indicate the relationship between utterance and prior discourse such as: but, therefore, in conclusion, to the contrary, however, besides, after all, etc.

For example:

"they boy stole a bike. Therefore, he was arrested yesterday".

Therefore functions as a connecting used to refer to certain discourse that contain the utterances or as a signal its relations to surrounding text.

3.5. Social deixis

Stephen C. Levinson (1983:89) stated that social deixis concerns with the aspects of sentences which reflect or establish or determined by certain realities of participants or the social situation in which the speech events occurs. He add that there are two basic kinds of social deixis information that seems to be encoded in language around the world. They are: Relational social deixis and Absolute social deixis. Relational deixis is adeictic references to some social characteristic of referent apart from any relative rangking of refrents or deictic reference to a social relationship between the speaker and addresse.

In English, relational social deixis may be a lexical items. For example, my husband, teacher, cousin etc. Pronouns (you, her). Absolute social deixis is a deictic reference usually expressed in certain forms of address which will include no comparison of the rangking of the speaker and addressee. For example; your highness, Mr. President, your majesty, etc. Briefly, social deixis is a deictic

expression used to distinct social status. Social deixis separated into two kinds relational and absolute social deixis.

4. Expression

An expression is any stretch of talk, by one persion, before and after which there is silence on the part of that person. An expression is unit of speech generally but not always bounded by breaths and pause it may be desribed as a complete unit of talk, sometimes bounded by the speake's silence. Every expression is mode within some specific context.

Malinowski (1923) stated that expression and situation are bound up inextricably with each other and the context of situation is indespesable for the understanding of the words. A word without linguistic context is a mere figment and stands for nothing bt itself. Some in reality of a spoken living tongue the expression has no meaning accept in the context of situation.

According to Taiwo (2007), studying an utterance without consideration for the context in which it is produced is like studying cardiovascular system as a complete seprate entity from any other part of human or animal anatomy. Uuterances are made by language user with a lot of assumption, yet communication goes on smoothly, because therever some naturally designed meant by which utterances are understood.

Through these means, people can understand even what is not said by using contextual cus, relying on their shared knowledge with the speaker(s) and the general world view. Pragmatic has made us to understand how we arrive at

meaning of utterances by relying on the context of such utterances. In short, to know the speaker's utterances the hearer must know the context.

5. Talk show

A talk show or chat show is a television programming or radio programming genre in which one person or group of people discusses various topics put forth by a talk show host. Usually, guests consist of a group op people who are learned or who have great experience in relation to whatever issue of being discussed on the show for that episode. Other times, a single guest discusses their work or area expertise with a host or co-hosts. A call-in show takes live phone calls from callers listening at home,, in their cars, etc. Sometimes, guests are already seated but are often introduced and enter from backstage. There have fun been many notable talk show hosts in many cases, the shows have made their hosts famous. One of them, Mata najwa talk show.

Mata najwa is a speech degree program guided by senior journalist, Najwa Shihab. The first season was broadcast premiere on Metri TV since November 25, 2009, Mata Najwa consistently brought interesting topics with first-class speakers. This talk show will be aired every Wednesday at 8:00 p.m until 21:30 p.m WIB. Present as a special sepeaker at Mata Najwa, 3rd RI President, Bacharuddin Jusuf Habibie (episode Habibie Today). 5th RI President Megawati Soekarno Putri (episode: what said Mega?), former vice president Boediono (episode: Di balik Diam Boediono, Deputy President Jusuf Kalla (episode: The Leader of the Courageous), Minister of BUMN Dahlan Iskan (episode: Commander Cowboy),

and Governor of DKI Jakarta who is now the President of Indonesia, Joko Widodo (episode: Laga Ibukota). Mata Najwa's first season officially ended on August 23, 2017 with thw decision of the guide (host) Mata Najwa for the approval of succes on MetroTV as well as the host of Mata Najwa. Mata Najwa's last episode on MetroTV was "Note without Points" which aired on August 30, 2017. Mata Najwa's second season was back on Trans7 starting January 10, 2018, with an episode titled "Indonesia Rumah Kita".

B. Previous Relevant Studies

Some resarchers have about deixis. The previous study was done on 2018 Deixis Interpretation on Donald Trump's speech, by using John I. Saeed theory. The study in this research explain kinds of deixis and the reason of deixis in Donald Trump's speech.

And the second reserach that has observed on 2018 Deixis in Adele's 21 Album, by using Cruse theory. The study in this paper explain the kinds of deixis, how was the deixis realized in Adele's 21 Album. The reaserch used descriptive qualitative method to describe the types of deixis.

C. Conceptual framework

The most important thing in analyzing conversation or speech event is knowing the context of the expression. Who is sepaking, who is the addressee, what is the topic, when the conversation is being held and where the conversation is located. Pragmatics is the study of relation between language and context that are grammaticalized, basic to an account of language understanding or encoded in

the structure of a language. Pragmatics is also the study of deixis, implicature, persuapposition, speech acts, and aspect of discourse structure.




Figure. 2.1 Conceptual Framework

Deixis is an important field of language study in its own right and has some relevance to analysis of conversation and pragmatics. It essentially concerns the ways in which language encode or grammaticalizes the features of the context of expression or speech event, and also concerns ways in which interpretation of expression depends on the analysis of the context of expression. As explained above, there are five types of deixis based on Levinson, they are person deixis, temporal deixs, spatial deixis, discourse deixis and social deixis. In this study, the research has Sandiaga Uno's expression performing in Talk Show TV Program ro find out the types of deixis he used. The conceptual framework to be followed in this study is summurized in figure 2.1 below.

CHAPTER III

METHOD OF RESEARCH

A. Research Design

This research will be conducted by using descriptive qualitative design.

Descriptive method described the situation or event, so this method accounts for the accumulator of the basic data.

B. Source of Data

The data of this study will be taken from video of Sandiaga Uno's performances in mata najwa talk show tv program which is uploaded in youtube. The video published on 28 February 2019 and accessed March 5th, 2019.

C. The Techniques of Data Collection

The data will be collected through some techniques, they are:

- 1. Downloading the video from youtube.
- 2. Watching the video and starting to transcribing it into written language.
- 3. Reading Sandiaga Uno's expression that have transcribed into written language.
- 4. Underlining Sandiaga Uno's expression that include the deixis.
- Classifying the types of deixis in Sandiaga Uno's expression based on Levinson's theory.

6. Identifying the most dominant deixis used by Sandiaga Uno's expression in mata najwa talk show.

D. The Techniques of Data Analysis

According to Creswell (2014) the procedures of data will be analyzed based on the following steps:

- 1. Organizing and prepare the data for analysis.
- 2. Reading or look at all the video of Sandiaga Uno's in mata najwa talk show.
- 3. Starting coding all of the data based on the types of deixis namely person deixis, temporal deixis, spatial deixis, social deixis and discourse deixis.
- 4. Using the coding process to generate a description.
- 5. Advance the description.
- 6. Making an interpretation of the finding or result.

CHAPTER IV

DATA AND DATA ANALYSIS

A. Data Collection

The data of this research were collacted from the video of Sandiaga Uno's in mata najwa talk show which uploaded in youtube. The data of this research are utterances of Sandiaga Uno's which transcribed into written language. There are total 85 utterances that used by Sandiaga Uno's in his performance in mata najwa talkshow.

The data classified into it's types of deixis. Based on the theory, there were five types of deixis namely; person deixis, spatial deixis, temporal deixis, discourse deixis and social deixis. The researcher analyzed some classification of deixis can be answered the formulation of the problem of this research, namely what kind of deixis used by Sandiaga Uno's expression in the talk show TV Program, how are the deixis used in the talk show TV Program and why are deixis in the way they are.

B. Data Analysis

Kinds of Deixis are used by Sandiaga Uno's expression in talk show TV Program.

After the collecting the data, the resarcher analyzed the data into it's types of deixis. Based on the theory, there were five types of deixis namely, person deixis,

spatial deixis, temporal deixis, discourse deixis and social deixis. Types of deixis in this research was determined from Sandiaga Uno's expression in talk show. Appendix II showed that the total number of deixis was 85 utterances with detail as follow the number of person deixis was 150, spatial deixis was 12, temporal deixis was 17, discourse deixis was 38 and social deixis was 19. The total number of types deixis showed in the table 4.1.

It was found that there are five types of deixis based on Levinso's theory about deixis that used in Sandiaga Uno's utterance. There are five types of deixis, they are person deixis, spatial deixis, temporal deixis, discourse deixis, and social deixis with the calculation and percentage, 150 (63.55%) of person deixis, 12 (5.08%) of spatial deixis, 17 (7.20%) of temporal deixis, 38 (16.10%) of discourse deixis and 19 (8.05%) of social deixis. The total calculation of deixis from

Sandiaga Uno's utterances are 236 deixis from 85 utterances. The following are examples of deixis used in talk show to program.

a. Person deixis

Person deixis refers to the people in Sandiaga Uno's expressions on the video mata najwa talk show. Person deixis divided into three divisions. They were first person singular/plural, second person singular/plural and third person singular/plural. The following were taken from Sandiaga Uno's expressions in the video.

1. First person singular/plural

Data 1: "I started the campaign at less than 40 % of people knew Sandiga Uno's throughtout Indonesia". The word include of first person which refers to the speakers and first person gave information to the listener. In this case, the speaker gave information that many people don't know Sandiaga Uno's. The word "I" that used by Sandiaga Uno's include singular person of first person deixis.

Data 2: "We want to convey the narrative new that Prabowo Sandi will present change economic Indonesia better". The word "we" in sandiaga Uno's utterances include into deixis. It can be be categorized into first person deixis the speaker using it to point the speaker.

"We also do not want to use the law to hit **our** opponents". The word "our" is spoken by Sandiaga Uno's. This word is a possessive pronoun that refers to

Sandiaga Uno's and Prabowo Supporters. The word "our" can be categorized into inclusive of person deixis.

2. Second person singular/plural

Data 3 "you have to do the same get the same level of recognition". The word "you" in Sandiaga Uno's utterances include into deixis. It can be categorized into second person deixis. Pronoun of "you" points more than one person.

3. Third singular/plural

Data 4 "What **they** really do and we have to apreciate infrastructure was not a massive job creatoer like Umkm". The word "they' refers to a presidential government that has built the infrastructure. The word "they" is deixis person because it points the people that not only exist in the talk show. "They" can be included into plural of person deixis, because pronoun "they" more than 2 people.

Data 5 "I always remaind **them** that main issue is the economics. The word "them" refers to Indonesian people. "Them" was person deixis. "Them" was third person plural and it was pronoun that refers to Indonesia people.

b. Spatial deixis

Theoritically, spatial deixis, where the relative location of people and things is being indicated. Spatial deixis can be marked of demonstrative pronouns such as "this" and "that". And also can be mareked of demonstrative adverbs of place such as "here" and "there". In this concept, there were 41 data of spatial deixis found in Sandiaga Uno's utterances, for example:

Data 6 "yesterday **in Maumere** there were five, then in **Kupang** there are four. So nine visits **in NTT**". The word Maumere, Kupang, NTT" spoken by Sandiaga Uno's that refers to his country which he will visit.

Data 7 "We might be part of **this room** part of the elite". From the word "**this room**" spoken by Sandiaga Uno's, it referred to *here* with show location. In this case the speaker namely Sandiaga Uno's spoke in front of the public that he part of the elite. "this room" show in mata najwa talk show.

Data 8 "Neno didn't mention of Prabowo and Sandi **there**". The word "there" was spatial deixis. The deictic word "there" refers to one of the locations of activities carried out by Neno Warisman.

c. Temporal deixis

Temporal deixis is the term of deixis that used to point to a time. Time deixis is deixis which shows the time in the speech. In this concept, there were 58 data of temporal deixis found in Sandiaga Uno's utterances, for example:

Data 9 "Good night, Assalamualaikum. Thank you for invited me on mata nazwa which hits really." From the example above, "Good night" show the timing of event relative to the speaking, in this case, Sandiaga Uno's spoke to the audiences who present on mata nazwa talk show. "

Data 10 "A 1320 visit point sir, for almost 12 **months**. Last almost six **months** with sir Anies." The word "month" refers to duration of something happen. So,

the researcher identified this word as temporal deixis. This word spoken by Sandiaga Uno's which refers to Sandiaga Uno's visit while campaign.

Data 11 "I always prayer **Friday** where a speech is flat" The word "firday" refers to the time which spoken by Sandiaga Uno's. "Friday" can be included into temporal deixis.

Data 12 "Although say I've been trying for **five years** still have to join the training" The word "year" refers to duration of something happen, this word as temporal deixis. This spoken by Sandiaga Uno's utterances.

d. Discourse deixis

Discourse, or text, deixis concerns the use of expressions within some utterances to refer to some portion of the discourse that contains that utterance (including the utterance itself). In this concept, there were 147 data of discourse deixis found in Sandiaga Uno's utterance, for example:

Data 13 "**But** people can see my self". From the example above, "But" refer to prior discourse.

Data 14 "**Moreover** the topic of politics, I am more minus about political topics". From the example above, "moreover" refer to prior discourse.

Data 15 "I think we cannot see the case and steeped in **this** case for different each case"

Data 16 "I see it not like **that**". From the example above "that, this" to the speakers current location in the discourse usually used in utterances.

e. Social deixis

The pronoun systems of some language also grammaticalized information about the social deixis identities or relationships of the participants in the conversation. In this concept, there were 75 data of Social deixis found in Sandiaga Uno's utterances. Social deixis concerns with the sentences that occurs in the social situation in which the speech events. For example:

Data 17 "How is the policy for farmers, fisherman"

Data 18 "I was present already register but have not yet been set as the vice president"

Data 19 "the issue of the criminalization of **the scholars of muslim** continues to be the subject of public" The example above "farmers, fishermen, scholar of muslim" refers to social deixis is a deictic expression used to distinct social status.

2. Realization of deixis used by Sandiaga Uno's expression in talk show to program

It is found that is a clause deixis occur more than one and occasionally more than once. Based on data analysis, there were 85 utterances with the number of person deixis was 150 utterances, spatial 12 utterances, temporal 17 utterances, discourse 38 utterances and social 19 utterances.

There were three example which put by researcher, such as:

You have to do the same to get the same level recognition. From the example above the satatement just have one clause. This religious problem i'm also confused as to why it keps coming out of elite conversation||if we see timeline.

From the example above it could be seen there were two clauses. The interpretasi I of this society||we leave it to member of the community || but if I see the behind but of which was delivered by Neno Warisman. From the example above the statement have three clauses.

3. The reason of deixis used by Sandiaga Uno's expression in talk show TV Program

Based on theory that the reason of deixis used in Sandiaga Uno's expression was in such a way. Because deixis in Sandiaga Uno's expression was very useful. By using the deixis in expression, the speaker and the audience would have the same understanding about the deixis. Deixis has function to identify the reference

of the utterance, which influence of meaning and information of the deixis. The deixis would be interesting if the listeners are easy to get the information of Sandiaga Uno's expressions. For example:

Moreover the topic of politics, I am more minus about political topics. From the example above, I refered to person deixis and directly spoke his expression. I used to refered to the speaker where the hearer know and understand the speaker. In addition, Sandiaga Uno's directly told the audience that he was weak about politic topic. And another example: Clearly that I was not present there.

From the example above *that* are referred to location. And this example was discourse deixis found in Sandiaga Uno's expression. It showed that any expression points to things or people in the context or situation in which the expression uttered. This example showed that *that* has meaning depend on context about event which to place.

C. Research Finding

After analysis of the data in this study, it can be argued some of finding as follows:

- 1. There were five types of deixis in Sandiaga Uno's. 85 data found in Sandiaga Uno's expression. Specifically 150 (63.55%) for person deixis, 12 (5.08%) for spatial deixis, 17 (7.20%) for temporal deixis, 38 (16.10%) for discourse deixis, 19 (8.05%) for social deixis.
- 2. The result of deixis realization used in Sandiaga Uno's expression in talk show TV Program, the researcher found that there were 45 (64.2%) of

- deixis in single clause, 21 (30%) of deixis in double clauses, 4 (5.7%) of deixis in tripple clause and not found deixis in quadrple clause.
- 3. The reason of deixis used in Sandiaga Uno's expression in talk show TV Program that deixis has function to identify the reference of the utterance, which influence of meaning and information of the deixis. The deixis would be interesting if the listeners are easy to get the information of Sandiaga Uno's expressions.

D. Discussion

This study deals with representation of deixis in Sandiaga Uno's expression in talk show tv program. The data were analyzed based on 5 kinds by Levinson (1983). This research were found that person was the most dominant types of deixis which found on video Sandiaga Uno's expression in talk show tv program. The deictic word "I" and "we" were the most dominant words of person deixis on Sandiaga Uno's expression in talk show tv program because the deictic word "I" refers to the speaker or Mr. Sandiaga Uno's that is vice president in Indonesia and the deictic "We" refer to the speaker snd his group or Mr. Sandiaga Uno's and some people of Indonesia.

CHAPTER V

CONCLUSIONS AND SUGGESTIONS

A. Conclusions

After analyzing the data conclution are drown as the following:

- 1. There were five types of deixis in Sandiaga Uno's. 85 data found in Sandiaga Uno's expression. Specifically 150 (63.55%) for person deixis, 12 (5.08%) for spatial deixis, 17 (7.20%) for temporal deixis, 38 (16.10%) for discourse deixis, 19 (8.05%) for social deixis.
- 2. The result of deixis realization in Sandiaga Umo's expression in talk show TV Program, the researcher found that there were 45 (64.2%) of deixis in single clause, 21 (30%) of deixis in double clauses, 4 (5.7%)of deixis in tripple deixis and not found deixis in quadrple clause.
- 3. The reason of deixis used in Sandiaga Uno's expression in talk show TV Program that deixis has function to identify the reference of the utterance, which influence of meaning and information of the deixis. The deixis would be interesting if the listeners are easy to get the information of Sandiaga Uno's expressions.

B. Suggestion

There are some points which suggested as follow:

- 1. The university students who were interested in studying pragmatics suggested to do further study.
- 2. The readers were expected to introduce them ehich referred to deixis and its realization in expressions.
- Other researchers, it can give surprising progress in pragmatics field and can be references for the to conduct in different object.
